PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 2) 2019

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Johor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 2) 2019**.

(2) Perintah ini mula berkuat kuasa pada 6 September 2019.

Pindaan Jadual Ketiga

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Ketiga di bawah kepala "**Negeri Johor Darul Takzim**"—

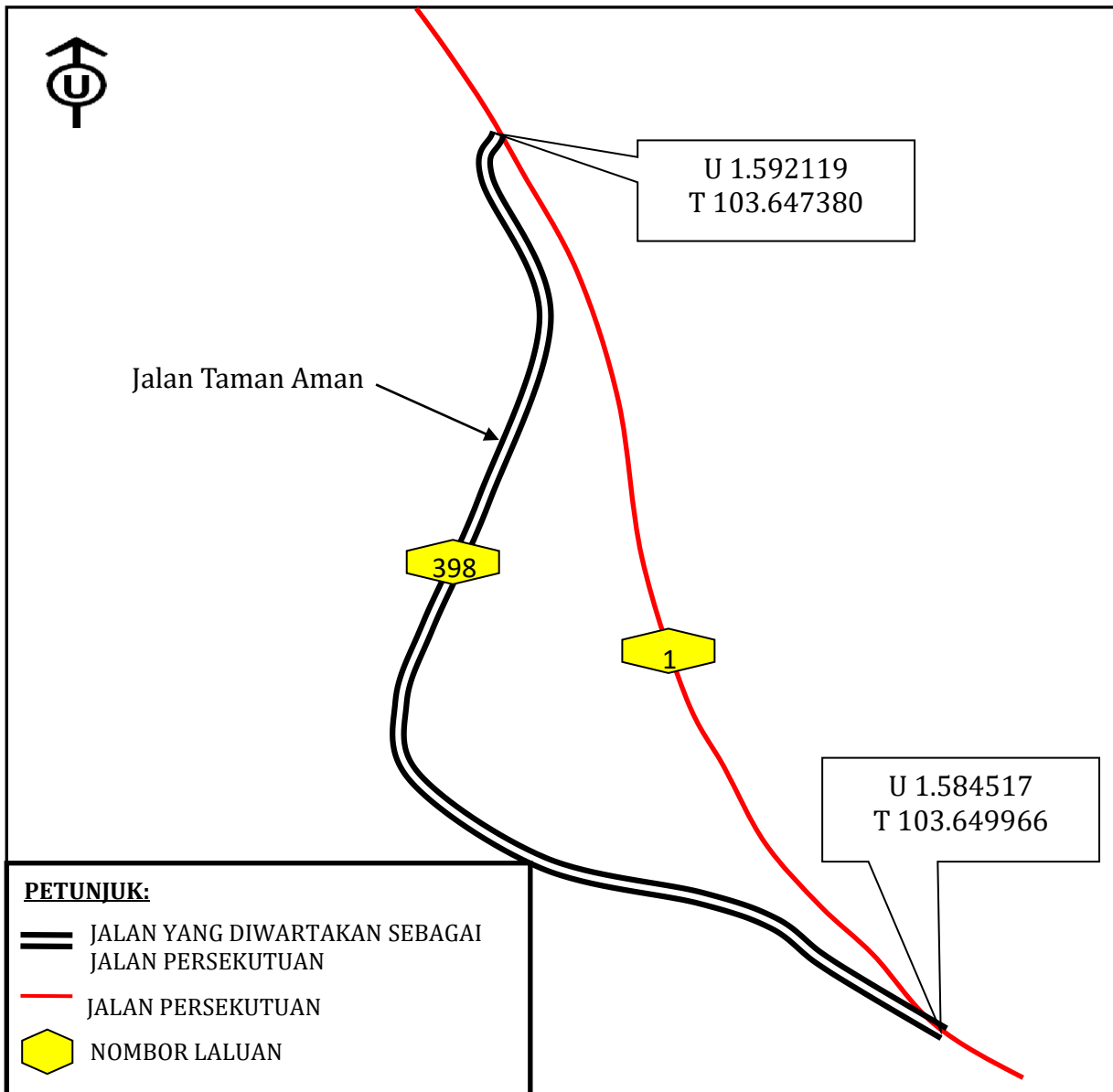
(a) dengan memasukkan selepas butiran 9 butiran yang berikut:

"10. (*Laluan 398*): *Jalan Taman Aman*

Dari koordinat U 1.584517, T 103.649966 dan berakhir di koordinat U 1.592119, T 103.647380 di dalam sempadan hak lalu-lalang sebagaimana yang ditunjukkan dalam PETA 2 : JALAN TAMAN AMAN (jarak sepanjang 1.06 km)."; dan

(b) dengan memasukkan selepas peta NEGERI JOHOR DARUL TAKZIM Peta Jalan-Jalan Persekutuan peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 2) ORDER 2019

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [*Act 376*], the Minister, after consultation with the State Government of Johore, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 2) Order 2019**.

(2) This Order comes into operation on 6 September 2019.

Amendment of Third Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the Third Schedule under the heading "**Negeri Johor Darul Takzim**"—

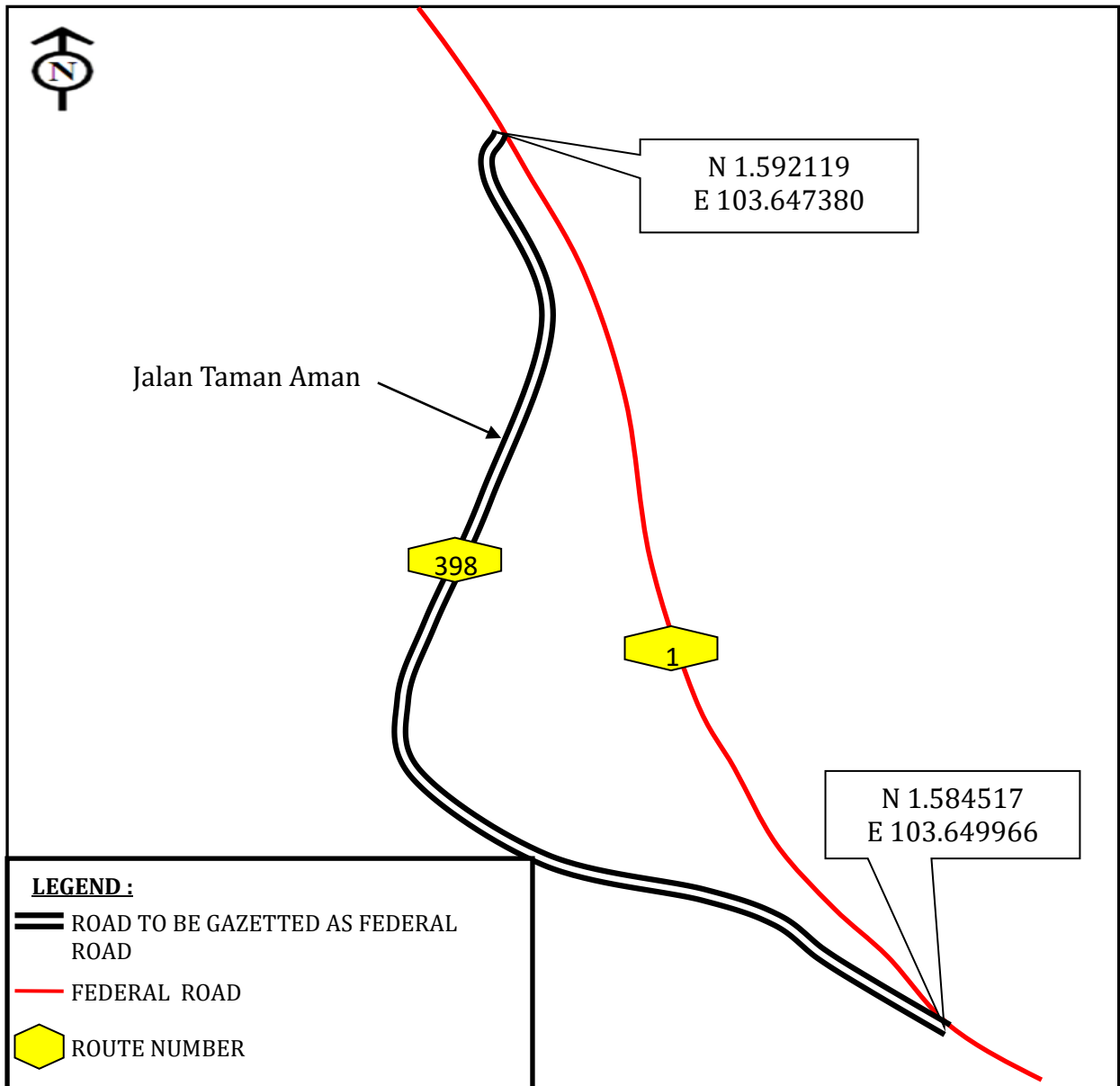
(a) by inserting after item 9 the following item:

"10. (*Route 398*): *Taman Aman Road*

From coordinates N 1.584517, E 103.649966 and ending at coordinates N 1.592119, E 103.647380 within the boundaries of right of way as shown on MAP 2 : TAMAN AMAN ROAD (a distance of 1.06 km)."; and

(b) by inserting after the map NEGERI JOHOR DARUL TAKZIM Federal Roads Map the following map:
