PERATURAN-PERATURAN BANK NEGARA MALAYSIA (PELAKSANAAN
KETETAPAN-KETETAPAN MAJLIS KESELAMATAN BANGSA-BANGSA BERSATU

PADA menjalankan kuasa yang diberikan oleh seksyen 82 Akta Bank Negara Malaysia 2009 [*Akta 701*], Bank Negara Malaysia, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Bank Negara Malaysia (Pelaksanaan Ketetapan Majlis Keselamatan Bangsa-Bangsa Bersatu yang berhubungan dengan Republik Demokratik Congo) (Pindaan) 2019**.

Pindaan peraturan 4

2. Peraturan-Peraturan Bank Negara Malaysia (Pelaksanaan Ketetapan-Ketetapan Majlis Keselamatan Bangsa-Bangsa Bersatu yang berhubungan dengan Republik Demokratik Congo) 2014 [*P.U. (A) 80/2014*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dengan menggantikan peraturan 4 dengan peraturan yang berikut:

“4. Orang yang ditentukan hendaklah seseorang individu atau sesuatu entiti yang telah ditentukan oleh Majlis Keselamatan atau Jawatankuasa Majlis Keselamatan di bawah Ketetapan sebagaimana yang disenaraikan dalam Senarai yang diwujudkan, disenggarakan dan dikemaskinikan oleh Jawatankuasa Majlis Keselamatan dan boleh didapati di laman sesawang rasmi Bangsa-Bangsa Bersatu di <http://www.un.org>.”

CENTRAL BANK OF MALAYSIA ACT 2009

CENTRAL BANK OF MALAYSIA (IMPLEMENTATION OF THE UNITED NATIONS
SECURITY COUNCIL RESOLUTIONS RELATING TO THE DEMOCRATIC REPUBLIC OF
CONGO) (AMENDMENT) REGULATIONS 2019

IN exercise of the powers conferred by section 82 of the Central Bank of Malaysia Act 2009 [*Act 701*], Bank Negara Malaysia, with the approval of the Minister, makes the following regulations:

Citation

1. These regulations may be cited as the **Central Bank of Malaysia (Implementation of the United Nations Security Council Resolutions relating to the Democratic Republic of Congo) (Amendment) Regulations 2019**.

Amendment of regulation 4

2. The Central Bank of Malaysia (Implementation of the United Nations Security Council Resolutions relating to the Democratic Republic of Congo) Regulations 2014 [*P.U. (A) 80/2014*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for regulation 4 the following regulation:

“4. A designated person shall be an individual who or an entity which has been designated by the Security Council or the Security Council Committee under the Resolutions as listed in the List which is established, maintained and updated by the Security Council Committee and made available on the official website of the United Nations at <http://www.un.org>.”

Deletion of Schedule

3. The principal Regulations are amended by deleting the Schedule.
