ROAD TRANSPORT ACT 1987

MOTOR VEHICLES (EXEMPTION OF *AD VALOREM* REGISTRATION FEES)  
(REVOCATION) RULES 2019

IN exercise of the powers conferred by paragraph 127(1)(b) of the Road Transport Act 1987 [*Act 333*], the Minister makes the following rules:

**Citation and commencement**

1. (1) These rules may be cited as the **Motor Vehicles (Exemption of *Ad Valorem* Registration Fees) (Revocation) Rules 2019**.

(2) These Rules come into operation on 1 July 2019.

**Revocation**

2. The Motor Vehicles (Exemption of *Ad Valorem* Registration Fees) Rules 1964 [*L.N. 134/1964*] are revoked.
