AKTA FUNGSI-FUNGSI MENTERI 1969

PERINTAH MENTERI-MENTERI KERAJAAN PERSEKUTUAN 2019

BAHAWASANYA menurut Perkara 43 dan 43A Perlembagaan Persekutuan, Yang di-Pertuan Agong telah melantik orang yang dinamakan dalam ruang pertama Jadual sebagai Menteri-Menteri dan Timbalan-Timbalan Menteri Kerajaan Persekutuan:

MAKA, OLEH YANG DEMIKIAN, pada menjalankan kuasa yang diberikan oleh seksyen 2 Akta Fungsi-Fungsi Menteri 1969 [*Akta 2*], Yang di-Pertuan Agong membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Menteri-Menteri Kerajaan Persekutuan 2019**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada tarikh pelantikan orang yang dinamakan dalam ruang pertama Jadual kepada nama jawatan yang dinyatakan dalam ruang kedua berhubung dengan jabatan dan perkara yang dipertanggungjawabkan dengan tanggungjawab kepada orang itu dalam ruang ketiga.

Fungsi-fungsi Menteri

2. (1) Diberitahu bahawa orang yang dinamakan dalam ruang pertama Jadual hendaklah mempunyai nama jawatan yang dinyatakan dalam ruang kedua bersetentangan dengan nama mereka masing-masing dalam Jadual.

(2) Orang yang namanya disebut dahulu dalam ruang pertama Jadual berhubung dengan mana-mana jabatan atau perkara yang dinyatakan dalam ruang ketiga yang bersetentangan dengan namanya hendaklah menjadi orang yang dipertanggungjawabkan dengan tanggungjawab bagi jabatan atau perkara itu dan hendaklah dibantu oleh orang yang namanya terdapat di bawah nama orang yang mula-mula disebut itu dalam ruang pertama.

Pembatalan

3. (1) Perintah Menteri-Menteri Kerajaan Persekutuan 2018 [*P.U. (A) 125/2018*] dibatalkan.

(2) Walau apa pun subperenggan (1), Perdana Menteri, Tun Dr. Mahathir bin Mohamad, hendaklah terus menjadi Menteri yang dipertanggungjawabkan dengan tanggungjawab mengenai—

(a) apa-apa fungsi yang tidak ditugaskan secara khusus kepada mana-mana Menteri di bawah Perintah ini atau mana-mana undang-undang bertulis lain; dan

(b) mana-mana jabatan Kerajaan Persekutuan yang tidak ditugaskan secara khusus kepada mana-mana Kementerian di bawah Perintah ini,

sehingga fungsi atau jabatan itu ditugaskan kepada mana-mana Menteri atau Kementerian, mengikut mana-mana yang berkenaan.

Kecualian dan peralihan

4. (1) Jika terdapat sesuatu sebutan tentang seseorang Menteri dengan sesuatu nama jawatan tertentu dalam mana-mana undang-undang bertulis berhubung dengan mana-mana fungsi di bawah undang-undang bertulis itu dan nama jawatan itu diubah melalui Perintah ini, sebutan itu hendaklah disifatkan sebagai sebutan tentang Menteri dengan nama jawatan yang baharu itu.

(2) Jika terdapat sesuatu sebutan tentang seseorang Menteri dengan sesuatu nama jawatan tertentu dalam mana-mana undang-undang bertulis berhubung dengan mana-mana fungsi di bawah undang-undang bertulis itu dan fungsi itu telah dipindahkan melalui Perintah ini kepada seorang Menteri yang lain, sebutan itu hendaklah disifatkan sebagai sebutan tentang Menteri yang kepadanya fungsi itu telah dipindahkan.

MINISTERIAL FUNCTIONS ACT 1969

MINISTERS OF THE FEDERAL GOVERNMENT ORDER 2019

WHEREAS the Yang di-Pertuan Agong has pursuant to Articles 43 and 43A of the Federal Constitution appointed the persons named in the first column of the Schedule as Ministers and Deputy Ministers of the Federal Government:

NOW, THEREFORE, in exercise of the powers conferred by section 2 of the Ministerial Functions Act 1969 [Act 2], the Yang di-Pertuan Agong makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Ministers of the Federal Government Order 2019**.

(2) This Order is deemed to have come into operation on the date of appointment of the persons named in the first column of the Schedule to the styles and titles of office specified in the second column in relation to departments and subjects charged with the responsibility to such persons in the third column.

Ministerial functions

2. (1) It is notified that the persons named in the first column of the Schedule shall have the styles and titles of office specified in the second column corresponding to their respective names in the Schedule.

(2) The person whose name is mentioned first in the first column of the Schedule in relation to any department or subject specified in the third column corresponding to his name shall be the person charged with the responsibility for that department or subject and shall be assisted by the persons whose names appear underneath that first mentioned person's name in the first column.

Revocation

3. (1) The Ministers of the Federal Government Order 2018 [*P.U. (A) 125/2018*] is revoked.

(2) Notwithstanding subparagraph (1), the Prime Minister, Tun Dr. Mahathir bin Mohamad, shall continue being the Minister charged with the responsibility in respect of—

(a) any functions which are not specifically assigned to any Minister under this Order or any other written law; and

(b) any departments of the Federal Government which are not specifically assigned to any Ministry under this Order,

until such function or department is assigned to any Minister or Ministry, as the case may be.

Saving and transitional

4. (1) Where there is a reference to a Minister with a particular style or title in any written law in relation to any functions under that written law and that style or title is changed by this Order, that reference shall be deemed to be a reference to the Minister with the new style or title.

(2) Where there is a reference to a Minister with a particular style or title in any written law in relation to any functions under that written law and the functions have been transferred by this Order to another Minister, that reference shall be deemed to be a reference to the Minister to whom the functions have been transferred.
