PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN)  
(PELANTIKAN SEMULA) 2019

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan) (Pelantikan Semula) 2019**.

**Pelantikan semula bagi pengambilalihan kawalan**

2. Suruhanjaya telah melantik semula Tetuan Jamal, Amin & Partners (No. Pendaftaran AF1067) untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Belia Nasional Berhad dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya berkuat kuasa mulai 31 Oktober 2018 hingga 30 Oktober 2019.

**Kos dan perbelanjaan**

3. Apa-apa kos dan perbelanjaan yang ditanggung oleh Suruhanjaya berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Belia Nasional Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL)  
(REAPPOINTMENT) ORDER 2019

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

**Citation**

1. This order may be cited as the **Co-operative Societies (Assumption of Control) (Reappointment) Order 2019**.

**Reappointment of assumption of control**

2. The Commission has reappointed Messrs. Jamal, Amin & Partners (Registration No. AF1067) to assume control of the whole of the property, business, activities and affairs of the Koperasi Belia Nasional Berhad and carry on the whole of its business, activities and affairs with effect from 31 October 2018 to 30 October 2019.

**Costs and expenses**

3. Any costs and expenses incurred by the Commission in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Belia Nasional Berhad as a first charge.
