PADA menjalankan kuasa yang diberikan oleh perenggan 4(a) dan (b) Akta Industri Biobahan Api Malaysia 2007 [Akta 666], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Industri Biobahan Api Malaysia (Peratusan Adunan dan Penggunaan Mandatori) (Pindaan Jadual) 2019**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Julai 2019.

2. Jadual kepada **Peraturan-Peraturan Industri Biobahan Api Malaysia (Peratusan Adunan dan Penggunaan Mandatori) 2019 [P.U. (A) 27/2019]** dipinda berhubung dengan butiran "B7" dengan menggantikan butir-butir dalam ruang (4) dan (5) masing-masing dengan butir-butir yang berikut:

MALAYSIAN BIOFUEL INDUSTRY ACT 2007

MALAYSIAN BIOFUEL INDUSTRY (BLENDING PERCENTAGE
AND MANDATORY USE) (AMENDMENT OF SCHEDULE) REGULATIONS 2019

IN exercise of the powers conferred by paragraphs 4(a) and (b) of the Malaysian Biofuel Industry Act 2007 [Act 666], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Malaysian Biofuel Industry (Blending Percentage and Mandatory Use) (Amendment of Schedule) Regulations 2019**.

(2) These Regulations come into operation on 1 July 2019.

Amendment of Schedule

2. Schedule to the **Malaysian Biofuel Industry (Blending Percentage and Mandatory Use) Regulations 2019 [P.U. (A) 27/2019]** is amended in relation to the item "B7" by substituting for the particulars in columns (4) and (5) respectively the following particulars:

(1) Type of biofuel blended with any other fuel	(2) Type of biofuel	(3) Percentage of the blended biofuel (%)	(4) Type of fuel blended with biofuel	(5) Activities in which the use of a biofuel blended with any other fuel shall be mandatory
B7	Metil Ester	6.8-7.0	"(i) Diesel Euro 5 (ii) Diesel Euro 2	(i) Land transportation (ii) Industry"
