AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) 2019

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) 2019**.

(2) Perintah ini mula berkuat kuasa pada 14 Mac 2019.

Pindaan Jadual

2. Perintah Duti Kastam (Pengecualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 67, dalam ruang (2)—

(a) dengan memasukkan koma bernoktah di hujung perenggan (xxvii); dan

(b) dengan memasukkan selepas perenggan (xxvii) perenggan yang berikut:

“(xxviii) PEXCO Sarawak N.V.;

(xxix) PTTEP HK Offshore Limited”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2019

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) Order 2019**.

(2) This Order comes into operation on 14 March 2019.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule, in relation to item 67, in column (2)—

(a) by inserting semi colon at the end of paragraph (xxvii); and

(b) by inserting after paragraph (xxvii) the following paragraphs:

“(xxviii) PEXCO Sarawak N.V.;

(xxix) PTTEP HK Offshore Limited”.
