PERINTAH KAWALAN HARGA DAN ANTIPENCATUTAN
(PENENTUAN HARGA RUNCIT MAKSIMUM BAGI PETROL DAN DIESEL) 2019

PADA menjalankan kuasa yang diberikan oleh seksyen 4 Akta Kawalan Harga dan Antipencatutan 2011 [*Akta 723*], Pengawal, dengan kelulusan Menteri, membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Harga Runcit Maksimum bagi Petrol dan Diesel) 2019**.

2. Harga runcit maksimum bagi petrol dan diesel hendaklah sebagaimana yang dinyatakan dalam Jadual.

PRICE CONTROL AND ANTI-PROFITEERING
(DETERMINATION OF MAXIMUM RETAIL PRICE FOR PETROL AND DIESEL)
ORDER 2019

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [*Act 723*], the Controller, with the approval of the Minister, makes the following order:

Citation

1. This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) Order 2019**.

Maximum retail price for petrol and diesel

2. The maximum retail price for petrol and diesel shall be as specified in the Schedule.

Revocation

3. The Price Control and Anti-Profiteering (Determination of Maximum Retail Price for Petrol and Diesel) (No. 23) Order 2018 [*P.U. (A) 195/2018*] published in the *Gazette* on 15 August 2018 is revoked.
