COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES) (REVOCATION) ORDER 2019

IN exercise of the powers conferred by section 28 of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504] and subsection 11(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Revocation) Order 2019**.

(2) This Order comes into operation on 9 February 2019.

**Revocation**

2. The Customs (Anti-Dumping Duties) Order 2015 [P.U. (A) 24/2015] is revoked.
