AKTA PERDAGANGAN STRATEGIK 2010

PERINTAH PERDAGANGAN STRATEGIK (PINDAAN JADUAL) 2019

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Perdagangan Strategik (Pindaan Jadual) 2019**.

(2) Perintah ini mula berkuat kuasa pada 15 Januari 2019.

STRATEGIC TRADE ACT 2010

STRATEGIC TRADE (AMENDMENT OF SCHEDULE) ORDER 2019

IN exercise of the powers conferred by section 56 of the Strategic Trade Act 2010 [*Act 708*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Strategic Trade (Amendment of Schedule) Order 2019**.

(2) This Order comes into operation on 15 January 2019.

Amendment of Schedule

2. The Strategic Trade Act 2010 is amended in the Schedule by inserting after item 10 the following items:
