PERATURAN-PERATURAN LOTERI
(PENDAFTARAN DAN PELESENAN MESIN PERJUDIAN) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 14 Akta Loteri 1952 [*Akta 288*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Loteri (Pendaftaran dan Pelesenan Mesin Perjudian) (Pindaan) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2019.

Penggantian Jadual Pertama

2. Peraturan-Peraturan Loteri (Pendaftaran dan Pelesenan Mesin Perjudian) 1973 [*P.U. (A) 161/1973*] dipinda dengan menggantikan Jadual Pertama dengan Jadual yang berikut:

LOTTERIES ACT 1952

LOTTERIES (REGISTRATION AND LICENSING OF GAMING MACHINES)
(AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by section 14 of the Lotteries Act 1952 [*Act 288*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Lotteries (Registration and Licensing of Gaming Machines) (Amendment) Regulations 2018**.

(2) These Regulations come into operation on 1 January 2019.

Substitution of First Schedule

2. The Lotteries (Registration and Licensing of Gaming Machines) Regulations 1973 [*P.U. (A) 161/1973*] are amended by substituting for the First Schedule the following Schedule:

6.	Fees for the duplicate of a permit or licence	150.00
