FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(MALAYSIA-SINGAPORE SECOND CROSSING BRIDGE AND EXPRESSWAY AND  
PERLING EXPRESSWAY) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Malaysia-Singapore Second Crossing Bridge and Expressway and Perling Expressway) (Amendment) (No. 2) Order 2018**.

(2) This Order is deemed to have come into operation on 13 February 2018.

**Substitution of Second Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Malaysia-Singapore Second Crossing Bridge and Expressway and Perling Expressway) Order 1998 [*P.U. (A) 97/1998*] is amended by substituting for the Second Schedule the following Schedule:
