FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(SHAH ALAM EXPRESSWAY) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Shah Alam Expressway) (Amendment) (No. 2) Order 2018**.

(2) This Order comes into operation on 1 January 2019.

**Amendment of First Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Shah Alam Expressway) Order 1999 [*P.U. (A) 69/1999*] is amended in the heading of Part II of the First Schedule by substituting for the words “31 DECEMBER 2018” the words “31 DECEMBER 2019”.
