**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Sultan Abdul Halim Mu'adzam Shah) (Pindaan) (No. 2) 2018**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2019.

**Pindaan Jadual Pertama**

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan Sultan Abdul Halim Mu'adzam Shah) 2014 [*P.U. (A) 84/2014*], yang disebut "Perintah ibu" dalam Perintah ini, dipinda dalam Jadual Pertama—

(a) dalam ruang (1), di bawah kepala "*Tempoh Operasi*", dengan menggantikan perkataan "1.4.2018 – 31.12.2018" dengan perkataan "1.1.2019 – 31.12.2019"; dan

(b) dalam ruang (2), di bawah kepala "Kelas 0", dengan menggantikan perkataan "1.70" dengan perkataan "-".

**Pindaan Jadual Kedua**

3. Jadual Kedua kepada Perintah ibu dipinda dalam ruang (1), di bawah kepala "*Tempoh Operasi*", dengan menggantikan perkataan "1.4.2014 – 31.12.2038" dengan perkataan "1.1.2019 – 31.12.2019".

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(JAMBATAN SULTAN ABDUL HALIM MU'ADZAM SHAH)  
(AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Jambatan Sultan Abdul Halim Mu'adzam Shah) (Amendment) (No. 2) Order 2018**.

(2) This Order comes into operation on 1 January 2019.

**Amendment of First Schedule**

2. The Federal Roads (Private Management) (Collection of Tolls) (Jambatan Sultan Abdul Halim Mu'adzam Shah) Order 2014 [*P.U. (A) 84/2014*], which is referred to as the "principle Order" in this Order, is amended in the First Schedule—

(a) in column (1), under the heading "*Period of Operation*", by substituting for the words "1.4.2018 – 31.12.2018" the words "1.1.2019 – 31.12.2019";  
and

(b) in column (2), under the heading "Class 0", by substituting for the word "1.70" the word "-".

**Amendment of Second Schedule**

3. The Second Schedule to the principal Order is amended in column (1), under the heading "*Period of Operation*", by substituting for the words "1.4.2014 – 31.12.2038" the words "1.1.2019 – 31.12.2019".
