FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(JAMBATAN SULTAN ABDUL HALIM MU'ADZAM SHAH) (AMENDMENT) ORDER 2018

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Jambatan Sultan Abdul Halim Mu'adzam Shah) (Amendment) Order 2018**.

(2) This Order is deemed to have come into operation on 1 April 2018.

Amendment of First Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Jambatan Sultan Abdul Halim Mu'adzam Shah) Order 2014 [P.U. (A) 84/2014] is amended in the First Schedule, in column (1), under the heading "*Period of Operation*", by substituting for the words "1.4.2014 – 31.3.2018" the words "1.4.2018 – 31.12.2018".
