AKTA RACUN 1952

PERATURAN-PERATURAN RACUN (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 35 Akta Racun 1952 [*Akta 366*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Racun (Pindaan) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2019.

Penggantian peraturan 28

2. Peraturan-Peraturan Racun 1952 [*L.N. 440/1952*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini dipinda dengan menggantikan peraturan 28 dengan peraturan yang berikut:

“Fees

28. (1) An application for a licence under the Act shall be accompanied by the following fees:

(a) RM300.00 for Type A licence;

(b) RM300.00 for Type B licence;

(c) RM20.00 for Type D licence; and

(d) RM300.00 for Type E licence.

(2) The fees paid under subregulation (1) shall not be refundable.”.

Pindaan Jadual Kedua

3. Jadual Kedua kepada Peraturan-Peraturan ibu dipinda—

- (a) berhubung dengan Lesen Jenis B, dengan memotong perkataan “Fee paid: RM100.00”;
- (b) berhubung dengan Lesen Jenis D, dengan memotong perkataan “Fee paid: RM20.00”; dan
- (c) berhubung dengan Lesen Jenis E, dengan memotong perkataan “Fee paid: RM100.00”.

POISONS ACT 1952

POISONS (AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by section 35 of the Poisons Act 1952 [*Act 366*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Poisons (Amendment) Regulations 2018**.

(2) These Regulations come into operation on 1 January 2019.

Substitution of regulation 28

2. The Poisons Regulations 1952 [*L.N. 440/1952*], which are referred to as the “principal Regulations” in these Regulations, are amended by substituting for regulation 28 the following regulation:

“Fees

28. (1) An application for a licence under the Act shall be accompanied by the following fees:

(a) RM300.00 for Type A licence;

(b) RM300.00 for Type B licence;

(c) RM20.00 for Type D licence; and

(d) RM300.00 for Type E licence.

(2) The fees paid under subregulation (1) shall not be refundable.”.

Amendment of Second Schedule

3. The Second Schedule to the principal Regulations is amended—

- (a) in relation to Type B Licence, by deleting the words “Fee paid: RM100.00”;
- (b) in relation to Type D Licence, by deleting the words “Fee paid: RM20.00”;
and
- (c) in relation to Type E Licence, by deleting the words “Fee paid: RM100.00”.
