AKTA UMUR PERSARAAN MINIMUM 2012

PERINTAH UMUR PERSARAAN MINIMUM (PENGECUALIAN) (NO. 2) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 18 Akta Umur Persaraan Minimum 2012 [*Akta 753*], Menteri membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Umur Persaraan Minimum (Pengecualian) (No. 2) 2018**.

Pengecualian

2. Menteri mengecualikan Malaysia Airports Holdings Berhad dengan nombor pendaftaran 487092-W daripada semua peruntukan Akta berkenaan dengan orang yang dinamakan dalam ruang (1) Jadual yang diambil kerja untuk suatu kontrak perkhidmatan bertempoh tetap, termasuk apa-apa pelanjutan, yang melebihi enam puluh bulan bagi jawatan yang dinyatakan dalam ruang (2).

MINIMUM RETIREMENT AGE ACT 2012

MINIMUM RETIREMENT AGE (EXEMPTION) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 18 of the Minimum Retirement Age Act 2012 [*Act 753*], the Minister makes the following order:

Citation

1. This order may be cited as the **Minimum Retirement Age (Exemption) (No. 2) Order 2018**.

Exemption

2. The Minister exempts Malaysia Airports Holdings Berhad with the registration number 487092-W from all provisions of the Act in respect of the persons named in column (1) of the Schedule who are employed on a fixed term contract of service, inclusive of any extension, of more than sixty months for the positions as specified in column (2).
