(INSURANS) (PINDAAN) (NO. 2) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 26(2) Akta Pampasan Pekerja 1952 [*Akta 273*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) (Pindaan) (No. 2) 2018**.

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 1 Januari 2018.

**Pindaan Jadual**

2. Perintah Pampasan Pekerja (Skim Pampasan Pekerja Asing) (Insurans) 2005 [*P.U. (A) 45/2005*] dipinda dalam Jadual—

(a) dengan memotong perkataan “Zurich Insurance Malaysia Berhad”;

(b) dengan memotong perkataan “MCIS Zurich Insurance Berhad”;

(c) dengan memotong perkataan “Prudential BSN Takaful Berhad”; dan

(d) dengan menggantikan perkataan “Overseas Assurance Corporation (Malaysia) Berhad (dikenali sebagai Great Eastern General Insurance (Malaysia) Berhad berkuat kuasa mulai 31 Julai 2017)” dengan perkataan “Zurich General Insurance Malaysia Berhad (yang mengambil alih Great Eastern General Insurance (Malaysia) Berhad)”.

WORKMEN'S COMPENSATION ACT 1952

WORKMEN'S COMPENSATION (FOREIGN WORKERS' COMPENSATION SCHEME)  
(INSURANCE) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by subsection 26(2) of the Workmen's Compensation Act 1952 [*Act 273*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) (Amendment) (No. 2) Order 2018**.

(2) This Order is deemed to have come into operation on 1 January 2018.

**Amendment of Schedule**

2. The Workmen's Compensation (Foreign Workers' Compensation Scheme) (Insurance) Order 2005 [*P.U. (A) 45/2005*] is amended in the Schedule—

(a) by deleting the words "Zurich Insurance Malaysia Berhad";

(b) by deleting the words "MCIS Zurich Insurance Berhad";

(c) by deleting the words "Prudential BSN Takaful Berhad"; and

(d) by substituting for the words "Overseas Assurance Corporation (Malaysia) Berhad (known as Great Eastern General Insurance (Malaysia) Berhad with effect from 31 July 2017)" the words "Zurich General Insurance Malaysia Berhad (that took over Great Eastern General Insurance (Malaysia) Berhad)".
