PRINTING PRESSES AND PUBLICATIONS
(CONTROL OF UNDESIRABLE PUBLICATIONS) (REVOCATION) ORDER 2018

IN exercise of the powers conferred by subsection 7(1) of the Printing Presses and Publications Act 1984 [Act 301], the Minister revokes the prohibition of printing, importation, production, reproduction, publishing, sale, issue, circulation, distribution or possession of publications specified in column (1) of the Schedule which have been published vide the Orders specified in column (2).
