AKTA JUALAN LANGSUNG DAN SKIM ANTI-PIRAMID 1993

PERATURAN-PERATURAN JUALAN LANGSUNG
(PENGKOMPAUNAN KESALAHAN-KESALAHAN) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 44(2) Akta Jualan Langsung dan Skim Anti-Piramid 1993 [*Akta 500*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Jualan Langsung (Pengkompunan Kesalahan-Kesalahan) (Pindaan) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2019.

Pindaan peraturan 1

2. Peraturan-Peraturan Jualan Langsung (Pengkompunan Kesalahan-Kesalahan) 1993 [*P.U. (A) 256/1993*], yang disebut sebagai “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 1 dengan memasukkan selepas perkataan “**Jualan Langsung**” perkataan “**dan Skim Anti-Piramid**”.

Pindaan peraturan 2

3. Peraturan-Peraturan ibu dipinda dengan menggantikan peraturan 2 dengan peraturan yang berikut:

“Kesalahan boleh kompaun

2. Kesalahan-kesalahan yang dilakukan di bawah seksyen 6, 17, 18, 19, 19A, 20, 22, 25 dan 37 Akta dan semua kesalahan yang dilakukan di bawah mana-mana Peraturan-Peraturan Jualan Langsung 1993 [*P. U. (A) 128/1993*] ditetapkan sebagai kesalahan boleh kompaun.”.

DIRECT SALES AND ANTI-PYRAMID SCHEME ACT 1993

DIRECT SALES (COMPOUNDING OF OFFENCES) (AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by subsection 44(2) of the Direct Sales and Anti-Pyramid Scheme Act 1993 [*Act 500*], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Direct Sales (Compounding of Offences) (Amendment) Regulations 2018**.

(2) These Regulations come into operation on 1 January 2019.

Amendment of regulation 1

2. The Direct Sales (Compounding of Offences) Regulations 1993 [*P.U (A) 256/1993*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 1 by inserting after the words “**Direct Sales**” the words “**and Anti-Pyramid Scheme**”.

Amendment of regulation 2

3. The principal Regulations are amended by substituting for regulation 2 the following regulation:

“Compoundable offences

2. The offences committed under sections 6, 17, 18, 19, 19A, 20, 22, 25 and 37 of the Act and all offences committed under the Direct Sales Regulations 1993 [*P. U. (A) 128/1993*] are prescribed as compoundable offences.”.
