PERINTAH HAKMILIK ANAK NEGERI LABUAN (PINDAAN JADUAL KEDUA) 2018

LABUAN NATIVE TITLE ACT 2007

LABUAN NATIVE TITLE (AMENDMENT OF SECOND SCHEDULE) ORDER 2018

IN exercise of the powers conferred by subsection 19(2) of the Labuan Native Title Act 2007 [Act 667], the Land Executive Committee makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Labuan Native Title (Amendment of Second Schedule) Order 2018**.

(2) This Order comes into operation on 5 November 2018.

Amendment of Second Schedule

2. Second Schedule to the Labuan Native Title Act 2007 is amended by inserting after the item “Sabah Development Bank Berhad” the following item:

“Public Sector Home Financing Board”.
