FEDERAL TERRITORY (PLANNING) (FEES FOR PURCHASE OF LOCAL PLAN)
RULES 2018

IN exercise of the powers conferred by section 16 and paragraph 64(2)(j) of the Federal Territory (Planning) Act 1982 [Act 267], the Commissioner of the City of Kuala Lumpur, with the approval of the Minister, makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Federal Territory (Planning) (Fees for Purchase of Local Plan) Rules 2018**.

(2) These Rules come into operation on 12 November 2018.

Fees

2. The fees for the purchase of a copy of the local plan under section 16 of the Act, that is Kuala Lumpur City Plan 2020 shall be as specified in the Schedule.
