KAEDAH-KAEDAH PENGANGKUTAN JALAN (MATA DEMERIT) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 35(2) dan 35A(2) Akta Pengangkutan Jalan 1987 [*Akta 333*], Menteri membuat kaedah-kaedah yang berikut:

Nama dan permulaan kuat kuasa

1. Kaedah-kaedah ini bolehlah dinamakan **Kaedah-Kaedah Pengangkutan Jalan (Mata Demerit) (Pindaan) 2018**.

Pindaan kaedah 5

2. Kaedah 5 Kaedah-Kaedah Pengangkutan Jalan (Mata Demerit) 2017 [*P.U. (A) 110/2017*] dipinda—

(a) dalam subkaedah (3)—

(i) dalam perenggan (a), dengan menggantikan perkataan “daripada tarikh terakhir orang itu melakukan suatu kesalahan berjadual” dengan perkataan “dari tarikh terakhir orang itu melakukan suatu kesalahan berjadual dan bagi tiap-tiap tempoh dua belas bulan berturut-turut selepas itu”; dan

(ii) dengan memasukkan selepas perkataan “jumlah mata demerit terkumpul pemegang lesen memandu itu” perkataan “bagi tiap-tiap tempoh dua belas bulan berturut-turut”; dan

(b) dalam subkaedah (4), dengan menggantikan perkataan “dalam tempoh” dengan perkataan “dalam mana-mana tempoh”.

ROAD TRANSPORT ACT 1987

ROAD TRANSPORT (DEMERIT POINTS) (AMENDMENT) RULES 2018

IN exercise of the powers conferred by subsections 35(2) and 35A(2) of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation and commencement

1. These rules may be cited as the **Road Transport (Demerit Points) (Amendment) Rules 2018**.

Amendment of rule 5

2. Rule 5 of the Road Transport (Demerit Points) Rules 2017 [P.U. (A) 110/2017] is amended—

(a) in subrule (3)—

(i) in paragraph (a), by substituting for the words “from the date of his last commission of a scheduled offence” the words “from the date of his last commission of a scheduled offence and for every period of twelve consecutive months after that”; and

(ii) by inserting after the words “total demerit points accumulated by the holder of the driving licence” the words “for every period of twelve consecutive months”; and

(b) in subrule (4), by substituting for the words “during the period” the words “during any period”.
