1. Perintah ini bolehlah dinamakan **Perintah Kesalahan yang berhubungan dengan Anugerah (Pindaan Jadual Pertama) 2018**.

**Pindaan Jadual Pertama**

2. Akta Kesalahan yang berhubungan dengan Anugerah 2017 dipinda dalam Jadual Pertama—

(a) dalam ruang "*Ketua Negara*"—

- (i) berhubung dengan negara "*Gambia*", dengan menggantikan perkataan "*President of the Republic of the Islamic Republic of The Gambia*" dengan perkataan "*President of the Republic of The Gambia*";
- (ii) berhubung dengan negara "*Guyana*", dengan menggantikan perkataan "*President of the Republic of Guyana*" dengan perkataan "*President of the Co-operative Republic of Guyana*";
- (iii) berhubung dengan negara "*Haiti*", dengan menggantikan perkataan "*Président Provisoire de la République d'Haïti*" dengan perkataan "*Président de la République d'Haïti*";

- (iv) berhubung dengan negara "*Libya*", dengan menggantikan perkataan "*President of the Presidency Council of the Government of National Accord of Libya*" dengan perkataan "*President of the Presidency Council of the Government of National Accord of the State of Libya*";
  - (v) berhubung dengan negara "*Portugal*", dengan menggantikan perkataan "*President of the Republic of Portugal*" dengan perkataan "*President of the Portuguese Republic*";
  - (vi) berhubung dengan negara "*Qatar*", dengan menggantikan perkataan "*Amir of the State of Qatar*" dengan perkataan "*Emir of the State of Qatar*";
  - (vii) berhubung dengan negara "*Rwanda*", dengan menggantikan perkataan "*Président de la République du Rwanda*" dengan perkataan "*President of the Republic of Rwanda*";
  - (viii) berhubung dengan negara "*Saudi Arabia*", dengan menggantikan perkataan "*King of Saudi Arabia and Prime Minister of the Kingdom of Saudi Arabia*" dengan perkataan "*King of Saudi Arabia and President of the Council of Ministers of the Kingdom of Saudi Arabia*";
  - (ix) berhubung dengan negara "*Sudan*", dengan menggantikan perkataan "*President of the Republic of Sudan*" dengan perkataan "*President of the Republic of the Sudan*"; dan
  - (x) berhubung dengan negara "*Thailand*", dengan menggantikan perkataan "*Chairman of the King's Privy Council*" dengan perkataan "*King Rama X*";
- (b) dengan memotong negara "*Swaziland*" dan butir-butir yang berhubungan dengannya; dan

- (c) dengan memasukkan selepas negara “Estonia” dan butir-butir yang berhubungan dengannya negara dan butir-butir yang berikut:

OFFENCES RELATING TO AWARDS ACT 2017

OFFENCES RELATING TO AWARDS  
(AMENDMENT OF FIRST SCHEDULE) ORDER 2018

IN exercise of the powers conferred by section 19 of the Offences relating to Awards Act 2017 [Act 787], the Yang di-Pertuan Agong makes the following order:

**Citation**

1. This order may be cited as the **Offences relating to Awards (Amendment of First Schedule) Order 2018**.

**Amendment of First Schedule**

2. The Offences relating to Awards Act 2017 is amended in the First Schedule—

(a) in the column “*Head of State*”—

- (i) in relation to the country “Gambia”, by substituting for the words “President of the Republic of the Islamic Republic of The Gambia” the words “President of the Republic of The Gambia”;
- (ii) in relation to the country “Guyana”, by substituting for the words “*President of the Republic of Guyana*” the words “President of the Co-operative Republic of Guyana”;
- (iii) in relation to the country “Haiti”, by substituting for the words “*Président Provisoire de la République d’Haïti*” the words “*Président de la République d’Haïti*”;
- (iv) in relation to the country “Libya”, by substituting for the words “President of the Presidency Council of the Government of National Accord of Libya” the words “President of the Presidency Council of the Government of National Accord of the State of Libya”;

- (v) in relation to the country “Portugal”, by substituting for the words “President of the Republic of Portugal” the words “President of the Portuguese Republic”;
- (vi) in relation to the country “Qatar”, by substituting for the words “Amir of the State of Qatar” the words “Emir of the State of Qatar”;
- (vii) in relation to the country “Rwanda”, by substituting for the words “*Président de la République du Rwanda*” the words “President of the Republic of Rwanda”;
- (viii) in relation to the country “Saudi Arabia”, by substituting for the words “King of Saudi Arabia and Prime Minister of the Kingdom of Saudi Arabia” the words “King of Saudi Arabia and President of the Council of Ministers of the Kingdom of Saudi Arabia”;
- (ix) in relation to the country “Sudan”, by substituting for the words “President of the Republic of Sudan” the words “President of the Republic of the Sudan”; and
- (x) in relation to the country “Thailand”, by substituting for the words “Chairman of the King’s Privy Council” the words “King Rama X”;
- (b) by deleting the country “Swaziland” and the particulars relating to it; and
- (c) by inserting after the country “Estonia” and the particulars relating to it the following country and particulars:

<i>Country</i>	<i>Head of State</i>
“Eswatini	Head of State of the Kingdom of Eswatini”
