PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 9) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Selangor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 9) 2018**.

(2) Perintah ini mula berkuat kuasa pada 17 Oktober 2018.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala “Negeri Selangor Darul Ehsan”—

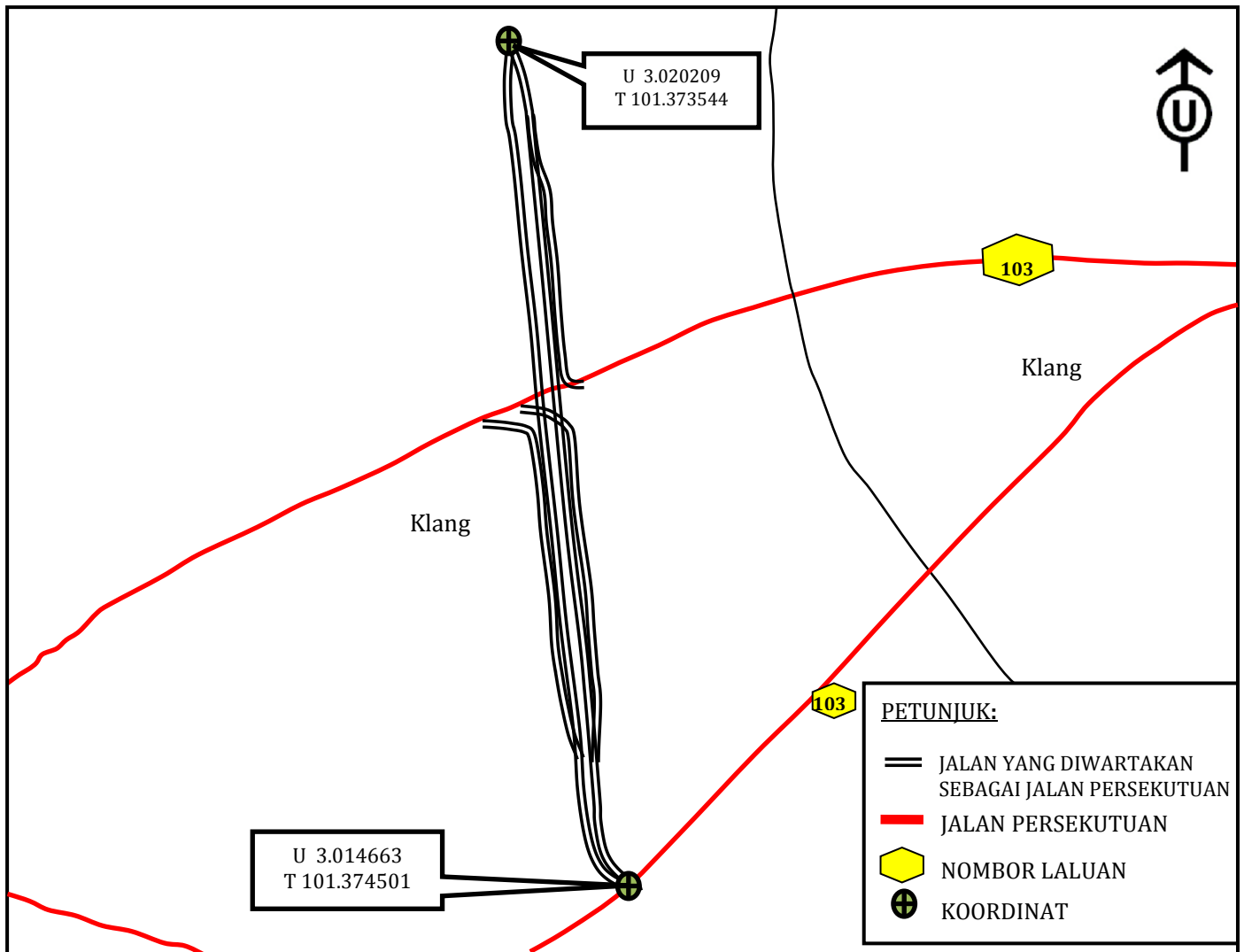
(a) dengan memasukkan selepas butiran 55 butiran yang berikut:

“56. (*Laluan 3220*): *Jalan Sultan Abdul Samad*

Dari koordinat U 3.014663, T 101.374501 dan berakhir di koordinat U 3.020209, T 101.373544 sebagaimana yang ditunjukkan dalam PETA 27: JALAN SULTAN ABDUL SAMAD, NEGERI SELANGOR (jarak sepanjang 0.637 km).”; dan

(b) dengan memasukkan selepas PETA 26: PUSINGAN U BERTINGKAT CHERAS, NEGERI SELANGOR peta yang berikut:

“PETA 27: JALAN SULTAN ABDUL SAMAD, NEGERI SELANGOR

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 9) ORDER 2018

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [*Act 376*], the Minister, after consultation with the State Government of Selangor, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 9) Order 2018**.

(2) This Order comes into operation on 17 October 2018.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule under the heading “Negeri Selangor Darul Ehsan”—

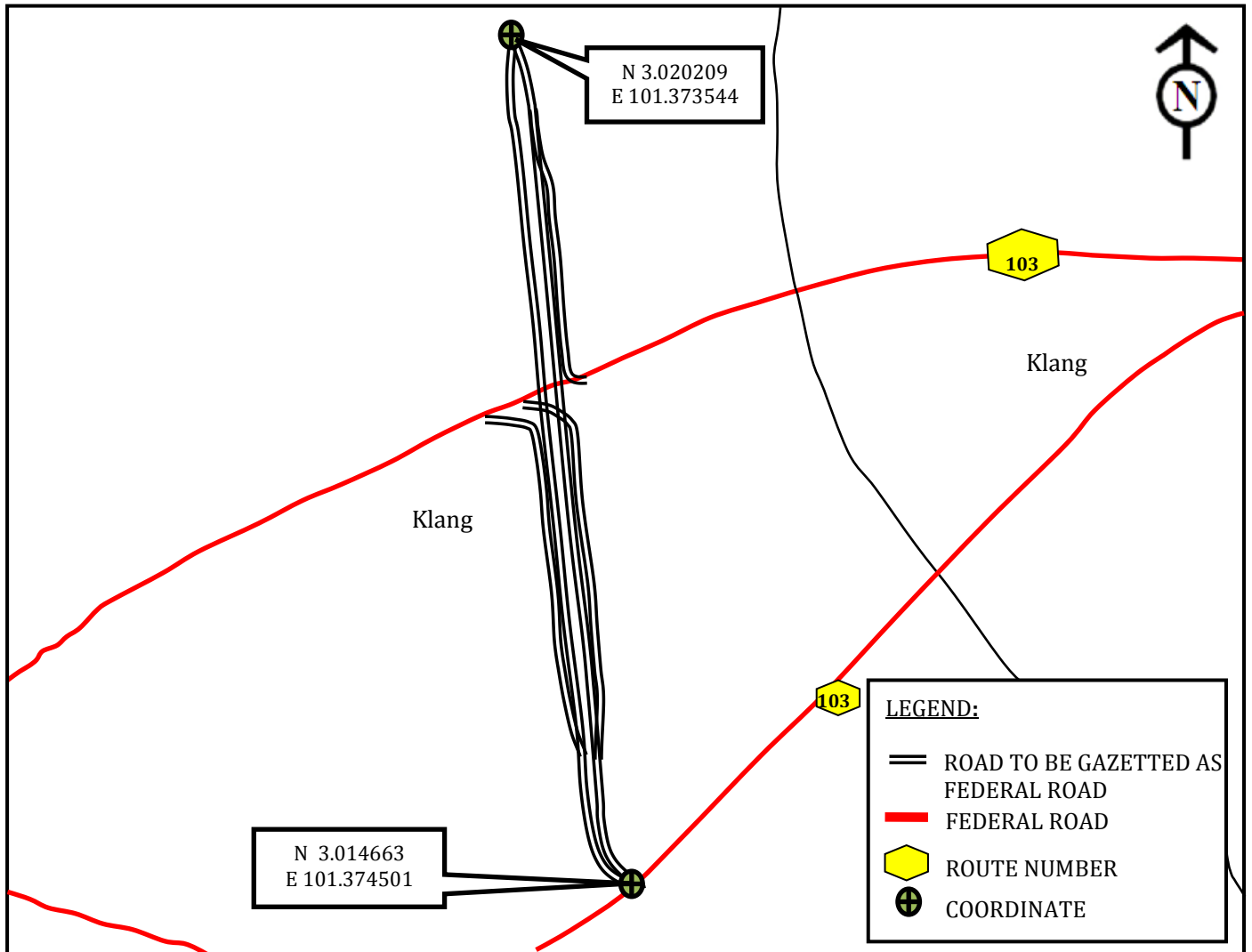
(a) by inserting after item 55 the following item:

“56. (*Route 3220*): *Sultan Abdul Samad Road*

From coordinates N 3.014663, E 101.374501 and ending at coordinates N 3.020209, E 101.373544 as shown on MAP 27: SULTAN ABDUL SAMAD ROAD, NEGERI SELANGOR (a distance of 0.637 km).”; and

(b) by inserting after MAP 26: CHERAS ELEVATED U-TURN, NEGERI SELANGOR the following map:
