SALES TAX (RATES OF TAX) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 10(2) of the Sales Tax Act 2018 [*Act 806*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Sales Tax (Rates of Tax) (Amendment) (No. 2) Order 2018**.

(2) This Order comes into operation on 9 October 2018.
