PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan) (Pelantikan Semula) (No. 2) 2018.**

Pelantikan semula bagi pengambilalihan kawalan

2. Suruhanjaya telah melantik semula Zainudin bin Mohamed untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Desa Lestari Kampung Seterpa Kota Bharu Berhad dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya berkuat kuasa mulai 30 Jun 2018 hingga 29 Jun 2019.

3. Apa-apa kos dan perbelanjaan yang dilakukan oleh Suruhanjaya berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Desa Lestari Kampung Seterpa Kota Bharu Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL)
(REAPPOINTMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

Citation

1. This order may be cited as the **Co-operative Societies (Assumption of Control) (Reappointment) (No. 2) Order 2018**.

Reappointment of assumption of control

2. The Commission has reappointed Zainudin bin Mohamed to assume control of the whole of the property, business, activities and affairs of the Koperasi Desa Lestari Kampung Seterpa Kota Bharu Berhad and carry on the whole of its business, activities and affairs with effect from 30 June 2018 to 29 June 2019.

Costs and expenses

3. Any costs and expenses incurred by the Commission in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Desa Lestari Kampung Seterpa Kota Bharu Berhad as a first charge.
