PERATURAN-PERATURAN KASTAM (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2018.

Citation and commencement
