PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 3) 2018

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 3) ORDER 2018

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 3) Order 2018**.

(2) This order comes into operation on 1 September 2018.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [*P.U. (A) 445/2017*] is amended in Part I of the Schedule—

(a) in relation to item 10, in column (3), by deleting paragraph (viii); and

(b) in relation to item 11, in column (3), by deleting paragraph (vii).
