AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (TRIBUNAL RAYUAN) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 141AB(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Tribunal Rayuan) (Pindaan) 2018**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 September 2018.

Pindaan peraturan 3

2. Peraturan-peraturan Kastam (Tribunal Rayuan) 2007 [*P.U. (A) 210/2007*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 3 dengan menggantikan perkataan “subseksyen 68(2) Akta Cukai Jualan 1972 [*Akta 64*] atau subseksyen 50(2) Akta Cukai Perkhidmatan 1972 [*Akta 151*]” dengan perkataan “subseksyen 96(5) Akta Cukai Jualan 2018 [*Akta 806*] atau subseksyen 81(5) Akta Cukai Perkhidmatan 2018 [*Akta 807*]”.

Pindaan peraturan 4

3. Subperaturan 4(1) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan “Akta Cukai Jualan 1972 atau Akta Cukai Perkhidmatan 1975” dengan perkataan “Akta Cukai Jualan 2018 atau Akta Cukai Perkhidmatan 2018”.

CUSTOMS ACT 1967

CUSTOMS REGULATIONS (APPEAL TRIBUNAL) (AMENDMENT) 2018

IN exercise of the powers conferred by subsection 141AB(1) of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs Regulations (Appeal Tribunal) (Amendment) 2018**.

(2) These Regulations come into operation on 1 September 2018.

Amendment of regulation 3

2. The Customs Regulations (Appeal Tribunal) 2007 [*P.U. (A) 210/2007*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 3 by substituting for the words “subsection 68(2) of the Sales Tax Act 1972 [Act 64] or subsection 50(2) of the Service Tax Act 1975 [Act 151]” the words “subsection 96(5) of the Sales Tax Act 2018 [Act 806] or subsection 81(5) of the Service Tax Act 2018 [Act 807]”.

Amendment of regulation 4

3. Subregulation 4(1) of the principal Regulations is amended by substituting for the words “the Sales Tax Act 1972 or the Service Tax Act 1975” the words “the Sales Tax Act 2018 or the Service Tax Act 2018”.
