PERINTAH ZON BEBAS (PENGECUALIAN BARANG DAN PERKHIDMATAN)  
(PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 6(1) Akta Zon Bebas 1990 [*Akta 438*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Zon Bebas (Pengecualian Barang dan Perkhidmatan) (Pindaan) 2018**.

(2) Perintah ini mula berkuat kuasa pada 1 September 2018.

**Pindaan perenggan 1**

2. Perintah Zon Bebas (Pengecualian Barang dan Perkhidmatan) 1998 [*P.U. (A) 459/1998*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 1(1) dengan memotong perkataan “**dan Perkhidmatan**”.

**Pindaan perenggan 2**

3. Perenggan 2 Perintah ibu dipinda dengan memotong perkataan “dan perkhidmatan”.

**Pindaan perenggan 3**

4. Perenggan 3 Perintah ibu dipinda—

(a) dalam nota bahu, dengan memotong perkataan “**dan perkhidmatan**”; dan

(b) dengan memotong perkataan “atau perkhidmatan”.

**Pindaan Jadual**

5. Jadual kepada Perintah ibu dipinda dalam butiran 11 dengan memotong perkataan “dan perkhidmatan”.

FREE ZONES ACT 1990

FREE ZONES (EXCLUSION OF GOODS AND SERVICES)  
(AMENDMENT) ORDER 2018

IN exercise of the powers conferred by subsection 6(1) of the Free Zones Act 1990 [*Act 438*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Free Zones (Exclusion of Goods and Services) (Amendment) Order 2018**.

(2) This Order comes into operation on 1 September 2018.

**Amendment of paragraph 1**

2. The Free Zones (Exclusion of Goods and Services) Order 1998 [*P.U. (A) 459/1998*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 1(1) by deleting the words “**and Services**”.

**Amendment of paragraph 2**

3. Paragraph 2 of principal Order is amended by deleting the words “and services”.

**Amendment of paragraph 3**

4. Paragraph 3 of principal Order is amended—

(a) in the shoulder note, by deleting the words “**and service**”; and

(b) by deleting the words “or services”.

**Amendment of Schedule**

5. The Schedule of principal Order is amended in item 11 by deleting the words “and services”.
