PERATURAN-PERATURAN ZON BEBAS (PINDAAN) 2018

FREE ZONES ACT 1990

FREE ZONES (AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by section 47 of the Free Zones Act 1990 [*Act 438*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Free Zones (Amendment) Regulations 2018**.

(2) These Regulations come into operation on 1 September 2018.

**Amendment of First Schedule**

2. The Free Zones Regulations 1991 [*P.U. (A) 321/1991*] are amended in the First Schedule under the heading "FORMS" by substituting for Form FZ No. 1 and Form FZ No.4 the following forms:
