MEDICAL ACT 1971

MEDICAL (AMENDMENT OF SECOND SCHEDULE) (NO. 3) ORDER 2018

IN exercise of the powers conferred by subsection 12(2) of the Medical Act 1971 [*Act 50*], the Minister, after consulting the Council, makes the following order:

Citation

1. This order may be cited as the **Medical (Amendment of Second Schedule) (No. 3) Order 2018**.
