## PERINTAH PERGIGIAN (PINDAAN JADUAL KEDUA) (NO. 2) 2018

2. Jadual Kedua kepada Akta Pergigian 1971 dipinda, berhubung dengan negara “India”—

## DENTAL ACT 1971

## DENTAL (AMENDMENT OF SECOND SCHEDULE) (NO. 2) ORDER 2018

IN exercise of the powers conferred by subsection 12(2) of the Dental Act 1971 [*Act 51*], the Minister, after consulting the Council, makes the following order:

**Citation**

1. This order may be cited as the **Dental (Amendment of Second Schedule) (No. 2) Order 2018**.

**Amendment of Second Schedule**

2. The Second Schedule to the Dental Act 1971 is amended in relation to the country of “India”—

(a) by substituting for the item “Vinayaka Missions University” and the particulars relating to it the following item and particulars:

“Vinayaka Missions Research Foundation that is deemed to be a university and which was formerly known as Vinayaka Missions University	Bachelor of Dental Surgery (B.D.S)”; and

(b) by substituting for the item “Manipal University, Manipal” and the particulars relating to it the following item and particulars:

qualification*

“Manipal Medical College, Manipal Academy of Higher Education that is deemed to be a university and which was formerly known as Manipal University, Manipal

Bachelor of Dental Surgery (B.D.S)”.
