PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 3) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [Akta 376], Menteri, setelah berunding dengan Kerajaan Negeri Selangor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 3) 2018**.

(2) Perintah ini mula berkuat kuasa pada 10 Julai 2018.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [P.U. (A) 401/1989] dipinda dalam Jadual Pertama di bawah kepala “Negeri Selangor Darul Ehsan”—

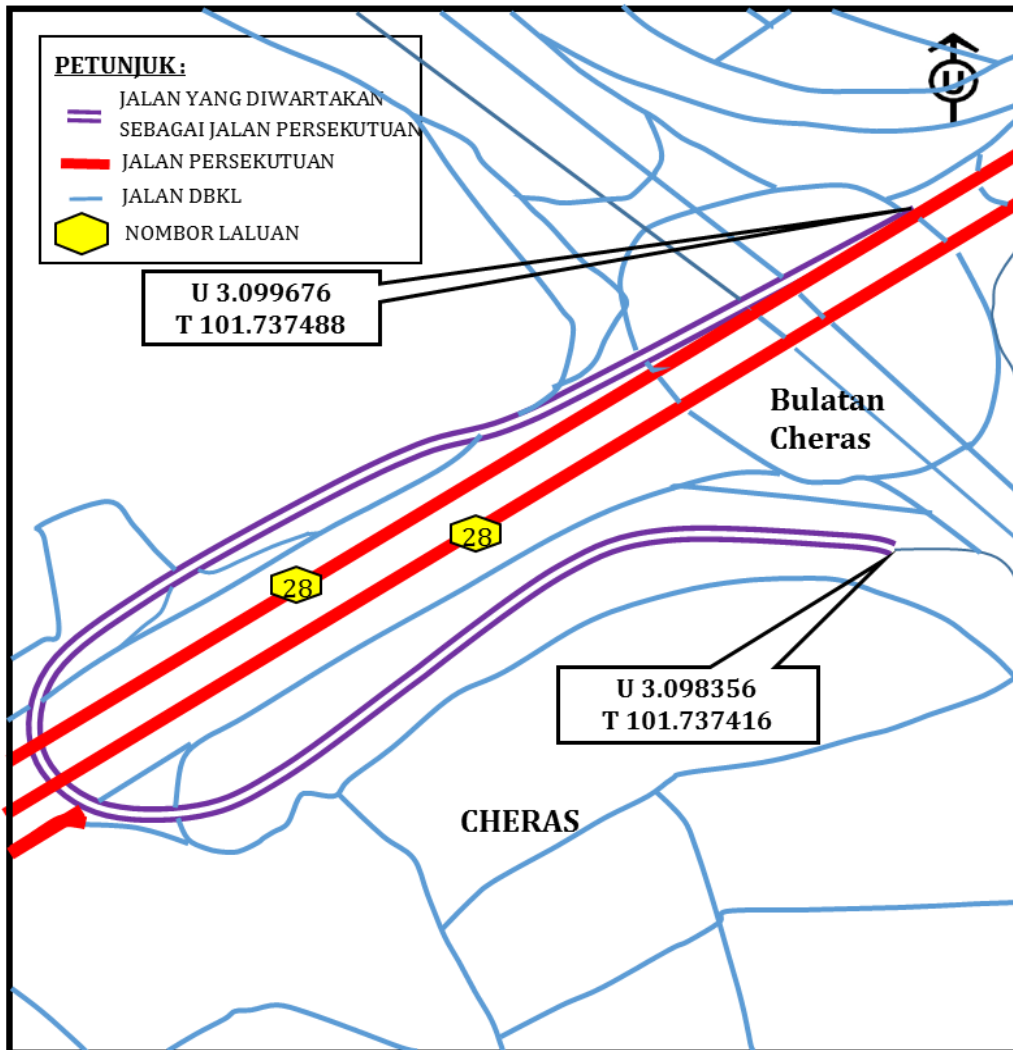
(a) dengan memasukkan selepas butiran 54 butiran yang berikut:

“55. *(Laluan 28): Pusingan U Bertingkat Cheras*

Bermula dari jalan masuk ke Laluan 28 di Bulatan Cheras di koordinat U 3.098356, T 101.737416 dan berakhir di Laluan 28 di koordinat U 3.099676, T 101.737488 sebagaimana yang ditunjukkan dalam Peta 26: PUSINGAN U BERTINGKAT CHERAS, NEGERI SELANGOR (jarak sepanjang 0.723 km)”; dan

(b) dengan memasukkan selepas PETA 25: JALAN RAWANG BYPASS, NEGERI SELANGOR peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 3) ORDER 2018

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Selangor, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 3) Order 2018**.

(2) This Order comes into operation on 10 July 2018.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “Negeri Selangor Darul Ehsan”—

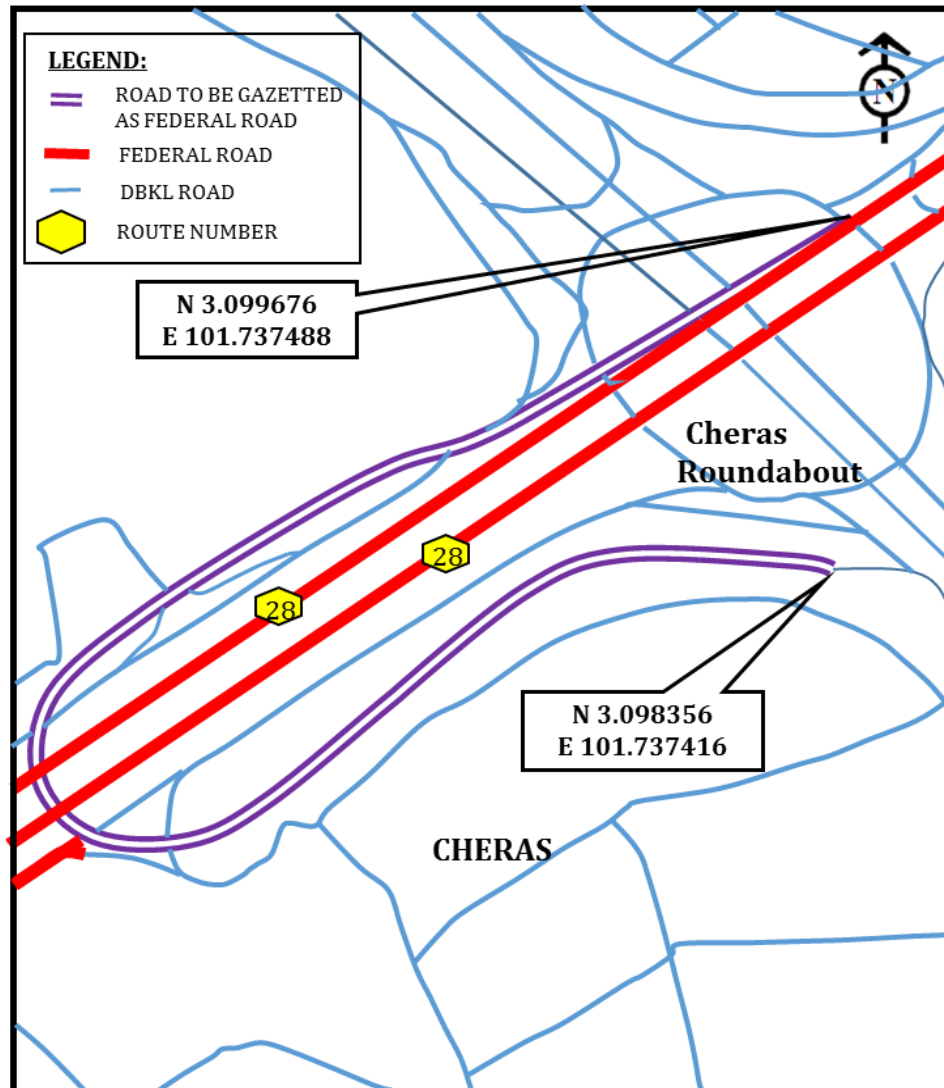
(a) by inserting after item 54 the following item:

“55. *(Route 28): Cheras Elevated U-Turn*

Starting from the entrance to Route 28 at Cheras Roundabout at coordinates N 3.098356, E 101.737416 and ending at Route 28 at coordinates N 3.099676, E 101.737488 as shown on Map 26 : CHERAS ELEVATED U-TURN, NEGERI SELANGOR (a distance of 0.723 km).”; and

(b) by inserting after MAP 25: RAWANG BYPASS ROAD, NEGERI SELANGOR the following map:
