PERINTAH KOPERASI (PENGAMBILALIHAN KAWALAN)  
(PELANTIKAN SEMULA) 2018

PADA menjalankan kuasa yang diberikan oleh perenggan 69(2)(a) dan subseksyen 69A(2) Akta Koperasi 1993 [*Akta 502*], Suruhanjaya membuat perintah yang berikut:

**Nama**

1. Perintah ini bolehlah dinamakan **Perintah Koperasi (Pengambilalihan Kawalan) (Pelantikan Semula) 2018**.

**Pelantikan semula bagi pengambilalihan kawalan**

2. Suruhanjaya telah melantik semula Mohd Shihabuddin bin Mohd Yazid untuk mengambil alih kawalan semua harta, urusan, aktiviti dan hal ehwal Koperasi Guru-Guru DTC Malaysia Berhad dan perbadanan yang berkaitan dengannya, dan menjalankan kesemua urusan, aktiviti dan hal ehwalnya berkuat kuasa mulai 30 Mac 2018 hingga 29 Mac 2019.

**Kos dan perbelanjaan**

3. Apa-apa kos dan perbelanjaan yang ditanggung oleh Suruhanjaya berhubung dengan pengambilalihan kawalan di bawah perenggan 2 hendaklah kena dibayar daripada dana dan harta Koperasi Guru-Guru DTC Malaysia Berhad sebagai suatu caj pertama.

CO-OPERATIVE SOCIETIES ACT 1993

CO-OPERATIVE SOCIETIES (ASSUMPTION OF CONTROL)  
(REAPPOINTMENT) ORDER 2018

IN exercise of the powers conferred by paragraph 69(2)(a) and subsection 69A(2) of the Co-operative Societies Act 1993 [Act 502], the Commission makes the following order:

**Citation**

1. This order may be cited as the **Co-operative Societies (Assumption of Control) (Reappointment) Order 2018**.

**Reappointment of assumption of control**

2. The Commission has reappointed Mohd Shihabuddin bin Mohd Yazid to assume control of the whole of the property, business, activities and affairs of the Koperasi Guru-Guru DTC Malaysia Berhad and its related corporations, and carry on the whole of its business, activities and affairs with effect from 30 March 2018 to 29 March 2019.

**Costs and expenses**

3. Any costs and expenses incurred by the Commission in relation to the assumption of control under paragraph 2 shall be payable out of the funds and properties of the Koperasi Guru-Guru DTC Malaysia Berhad as a first charge.
