PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 2) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Pahang, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 2) 2018**.

(2) Perintah ini mula berkuat kuasa pada 23 April 2018.

**Pindaan Jadual Pertama**

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama di bawah kepala “Negeri Pahang Darul Makmur”—

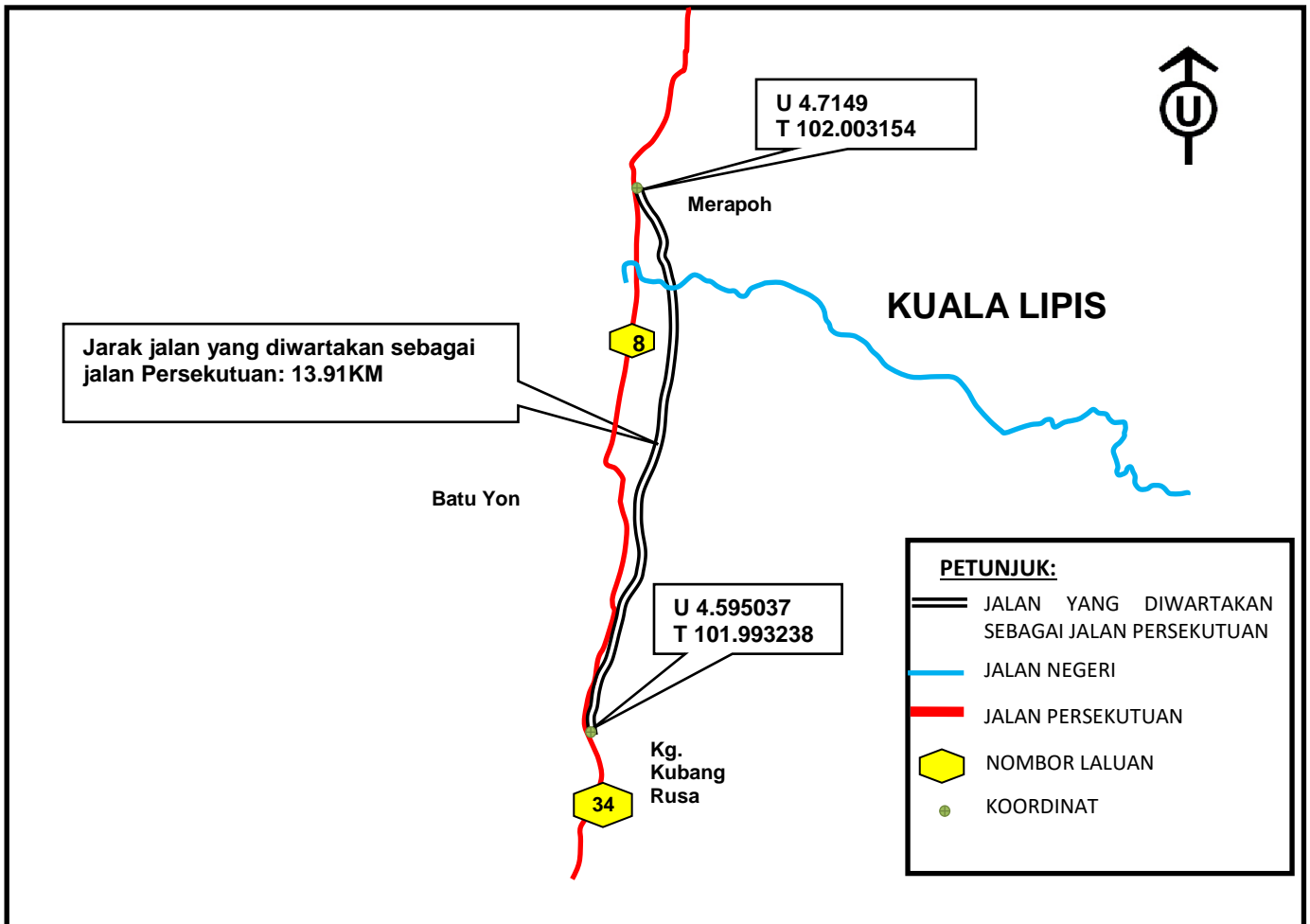
(a) dengan memasukkan selepas butiran 45 butiran yang berikut:

“46. (*Laluan 34*): *Jalan Central Spine*

Bermula dari Merapoh di Laluan 8 di koordinat U 4.7149, T 102.003154 dan berakhir di Kampung Kubang Rusa di Laluan 34 di koordinat U 4.595037, T 101.993238 sebagaimana yang ditunjukkan dalam PETA 24: JALAN CENTRAL SPINE, NEGERI PAHANG (jarak sepanjang 13.91 km).”; dan

(b) dengan memasukkan selepas PETA 23: NEGERI PAHANG dengan peta yang berikut:

“PETA 24: JALAN CENTRAL SPINE, NEGERI PAHANG

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [Act 376], the Minister, after consultation with the State Government of Pahang, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 2) Order 2018**.

(2) This Order comes into operation on 23 April 2018.

**Amendment of First Schedule**

2. The Federal Roads (West Malaysia) Order 1989 [P.U. (A) 401/1989] is amended in the First Schedule under the heading “Negeri Pahang Darul Makmur”—

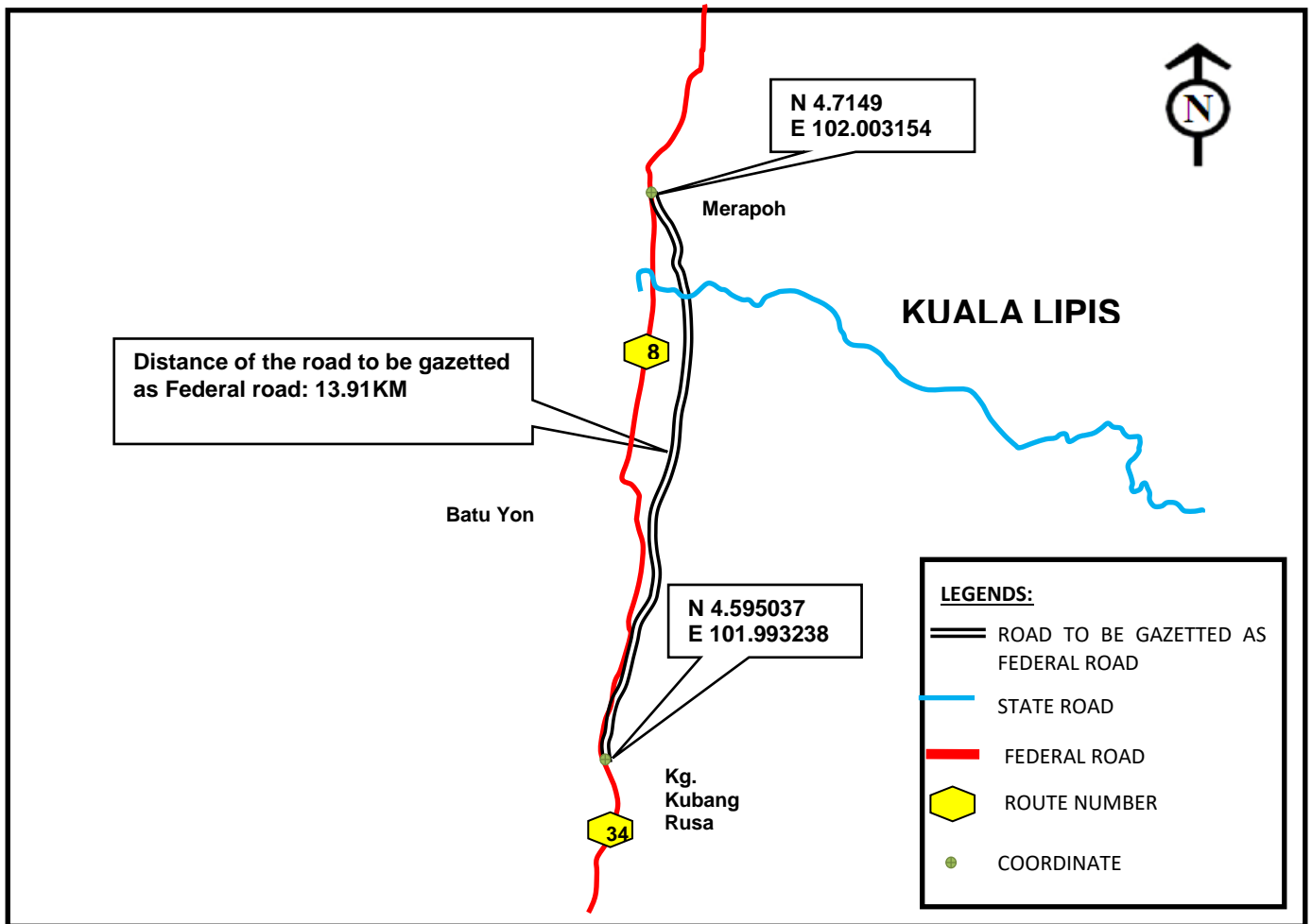
(a) by inserting after item 45 the following item:

“46. *(Route 34): Jalan Central Spine*

Starting from Merapoh at Route 8 at coordinates N 4.7149, E 102.003154 and ending at Kampung Kubang Rusa at Route 34 at coordinates N 4.595037, E 101.993238 as shown on MAP 24 : JALAN CENTRAL SPINE, NEGERI PAHANG (a distance of 13.91 km).”; and

(b) by inserting after MAP 23: NEGERI PAHANG the following map:
