Nama dan pemakaian

1. (1) Perintah ini bolehlah dinamakan **Perintah Perizaban Melayu (Wilayah Persekutuan) (Pindaan Jadual Ketiga) 2018**.

(2) Perintah ini hendaklah terpakai bagi Wilayah Persekutuan Kuala Lumpur.

MALAY RESERVATIONS ENACTMENT

MALAY RESERVATIONS (FEDERAL TERRITORY)
(AMENDMENT OF THIRD SCHEDULE) ORDER 2018

IN exercise of the powers conferred by section 7 of the Malay Reservations Enactment [*F.M.S. Cap. 142*], as modified by the Federal Territory (Modification of Malay Reservations Enactment) Order 1974 [*P.U. (A) 60/1974*], the Yang di-Pertuan Agong makes the following order:

Citation and application

1. (1) This order may be cited as the **Malay Reservations (Federal Territory) (Amendment of Third Schedule) Order 2018**.

(2) This Order shall apply to the Federal Territory of Kuala Lumpur.

Amendment of Third Schedule

2. The Third Schedule to the Malay Reservations Enactment is amended by adding the following:

“Dynasty Anchor Sdn. Bhd.
Koperasi Co-opbank Persatuan Malaysia Berhad
Perbadanan Nasional Berhad
Small Medium Enterprise Development Bank Malaysia Berhad
Mashyur Eramas Sdn. Bhd.
Qiana Development Sdn. Bhd.”.
