ROAD TRANSPORT ACT 1987

MOTOR VEHICLES (REGISTRATION AND LICENSING) (AMENDMENT)
RULES 2018

IN exercise of the powers conferred by paragraphs 66(1)(o) and (p) of the Road Transport Act 1987 [Act 333], the Minister makes the following rules:

Citation and commencement

1. (1) These rules may be cited as the **Motor Vehicles (Registration and Licensing) (Amendment) Rules 2018**.

(2) Except for subparagraphs 2(b)(iii)(B) and (c)(iii)(B), these Rules come into operation on 16 April 2018.

(3) Subparagraphs 2(b)(iii)(B) and (c)(iii)(B) are deemed to have come into operation on 1 April 2018.
