## PERATURAN-PERATURAN PERDAGANGAN STRATEGIK (RESOLUSI MAJLIS KESELAMATAN PERTUBUHAN BANGSA-BANGSA BERSATU) (PINDAAN) 2018

PADA menjalankan kuasa yang diberikan oleh seksyen 55 Akta Perdagangan Strategik 2010 [*Akta 708*], Menteri membuat peraturan-peraturan yang berikut:

**Nama**

1. Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Perdagangan Strategik (Resolusi Majlis Keselamatan Pertubuhan Bangsa-Bangsa Bersatu) (Pindaan) 2018**.

**Pindaan peraturan 3**

2. Peraturan 3 Peraturan-Peraturan Perdagangan Strategik (Resolusi Majlis Keselamatan Pertubuhan Bangsa-Bangsa Bersatu) 2010 [*P.U. (A) 481/2010*] dipinda—

(a) dalam perenggan (2)(a), (b) dan (c), dengan menggantikan perkataan “warganegara Malaysia dan tiada pertubuhan perbadanan yang diperbadankan di Malaysia” dengan perkataan “seorang pun”; dan

(b) dalam perenggan (2)(d)—

(i) dengan menggantikan perkataan “warganegara Malaysia dan tiap-tiap pertubuhan perbadanan yang diperbadankan di Malaysia” dengan perkataan “orang”; dan

(ii) dalam subperenggan (i), dengan menggantikan perkataan “dalam milikan, jagaan atau kawalannya yang mereka mempunyai” dengan perkataan “dalam milikan, jagaan atau kawalannya yang dia mempunyai”.

STRATEGIC TRADE ACT 2010

STRATEGIC TRADE (UNITED NATIONS SECURITY COUNCIL RESOLUTIONS)  
(AMENDMENT) REGULATIONS 2018

IN exercise of the powers conferred by section 55 of the Strategic Trade Act 2010 [*Act 708*], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Strategic Trade (United Nations Security Council Resolutions) (Amendment) Regulations 2018**.

**Amendment of regulation 3**

2. Regulation 3 of the Strategic Trade (United Nations Security Council Resolutions) Regulations 2010 [*P.U. (A) 481/2010*] is amended—

(a) in paragraphs (2)(a), (b) and (c), by substituting for the words “citizen of Malaysia and no body corporate incorporated in Malaysia” the word “person”; and

(b) in paragraph (2)(d)—

(i) by substituting for the words “citizen of Malaysia and every body corporate incorporated in Malaysia” the word “person”; and

(ii) in subparagraph (i), by substituting for the words “in their possession, custody or control that they have” the words “in his possession, custody or control that he has”.
