PRIVATE EMPLOYMENT AGENCIES ACT 1981

PRIVATE EMPLOYMENT AGENCIES (REVOCATION) REGULATIONS 2018

IN exercise of the powers conferred by subsection 27(1) of the Private Employment Agencies Act 1981 [*Act 246*], the Minister makes the following regulations:

**Citation and commencement**

1. (1) These regulations may be cited as the **Private Employment Agencies (Revocation) Regulations 2018**.

(2) These Regulations come into operation on 1 February 2018.

**Revocation**

2. The Private Employment Agencies Regulations 1981 [*P.U. (A) 214/1981*] are revoked.
