PERATURAN-PERATURAN SURUHANJAYA SEKURITI MALAYSIA
(LEMBAGA PEMANTAUAN AUDIT) (FI) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 159 Akta Suruhanjaya Sekuriti Malaysia 1993 [*Akta 498*], Suruhanjaya, dengan kelulusan Menteri, membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

SECURITIES COMMISSION MALAYSIA ACT 1993

SECURITIES COMMISSION MALAYSIA (AUDIT OVERSIGHT BOARD) (FEES)
REGULATIONS 2017

IN exercise of the powers conferred by section 159 of the Securities Commission Malaysia Act 1993 [*Act 498*], the Commission, with the approval of the Minister, makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Securities Commission Malaysia (Audit Oversight Board) (Fees) Regulations 2017**.

(2) These Regulations come into operation on 2 January 2018.

Fees

2. The fees payable in respect of the matters specified in column (2) of the Schedule shall be as specified in column (3) of the Schedule.

Revocation

3. The Securities Commission (Audit Oversight Board) (Fees) (No. 2) Regulations 2010 [*P.U. (A) 336/2010*] are revoked.
