PERINTAH JALAN PERSEKUTUAN (MALAYSIA BARAT) (PINDAAN) (NO. 8) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 3 Akta Jalan Persekutuan 1959 [*Akta 376*], Menteri, setelah berunding dengan Kerajaan Negeri Kedah dan Johor, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan Persekutuan (Malaysia Barat) (Pindaan) (No. 8) 2017**.

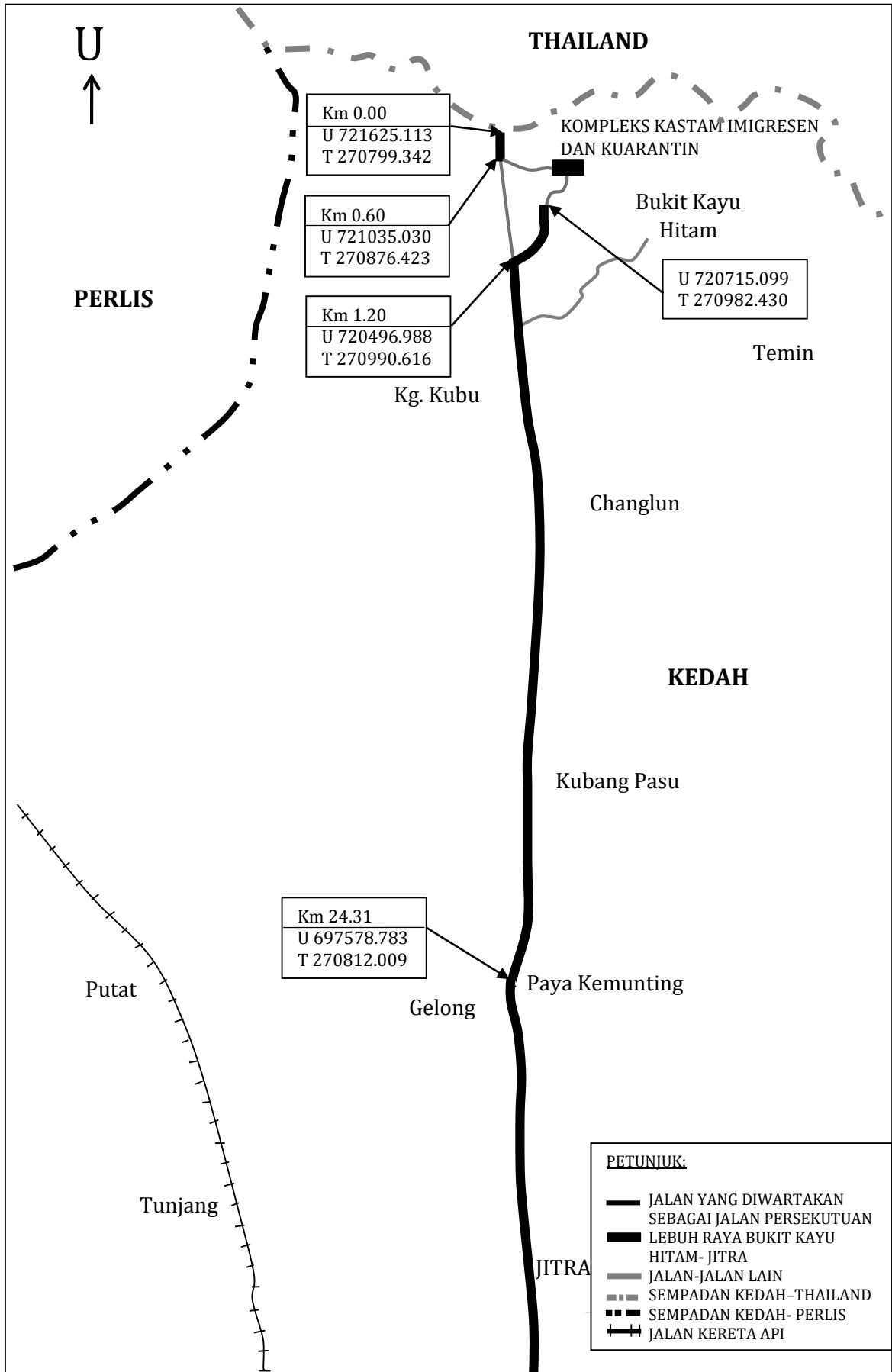
(2) Perintah ini mula berkuat kuasa pada 1 Januari 2018.

Pindaan Jadual Pertama

2. Perintah Jalan Persekutuan (Malaysia Barat) 1989 [*P.U. (A) 401/1989*] dipinda dalam Jadual Pertama—

(a) di bawah kepala “Negeri Kedah Darul Aman” dengan menggantikan PETA: LEBUH RAYA BUKIT KAYU HITAM-JITRA dengan peta yang berikut:

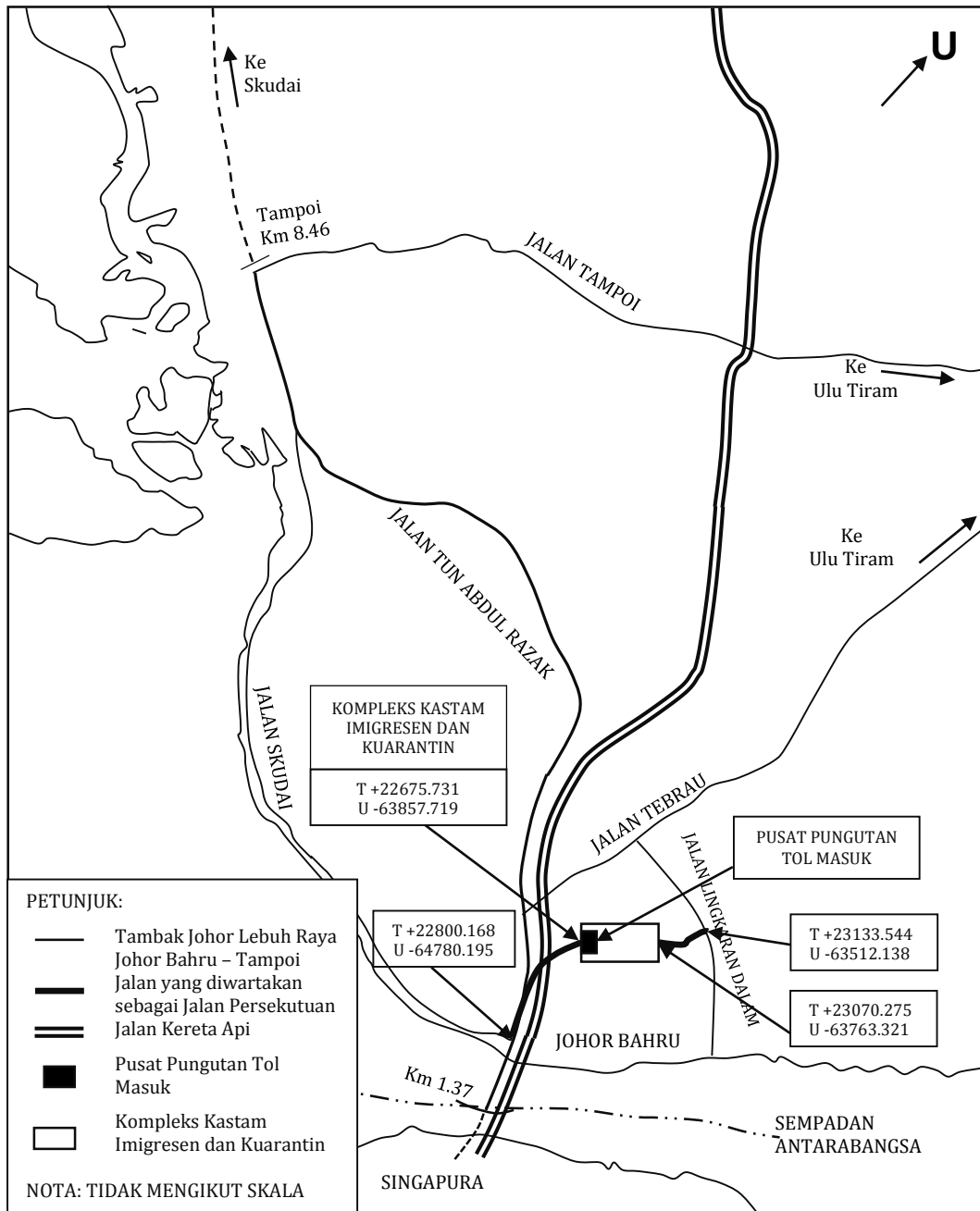

- (b) di bawah kepala “Negeri Johor”—
- (i) dalam butiran 30, dengan memasukkan selepas perkataan “Kompleks Kastam Imigresen dan Kuarantin” perkataan “yang dikenali sebagai Bangunan Sultan Iskandar”; dan
 - (ii) dengan menggantikan PETA 8: JALAN-JALAN PERSEKUTUAN NEGERI JOHOR dengan peta yang berikut:

FEDERAL ROADS ACT 1959

FEDERAL ROADS (WEST MALAYSIA) (AMENDMENT) (NO. 8) ORDER 2017

IN exercise of the powers conferred by section 3 of the Federal Roads Act 1959 [*Act 376*], the Minister, after consultation with the Governments of the States of Kedah and Johore, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (West Malaysia) (Amendment) (No. 8) Order 2017**.

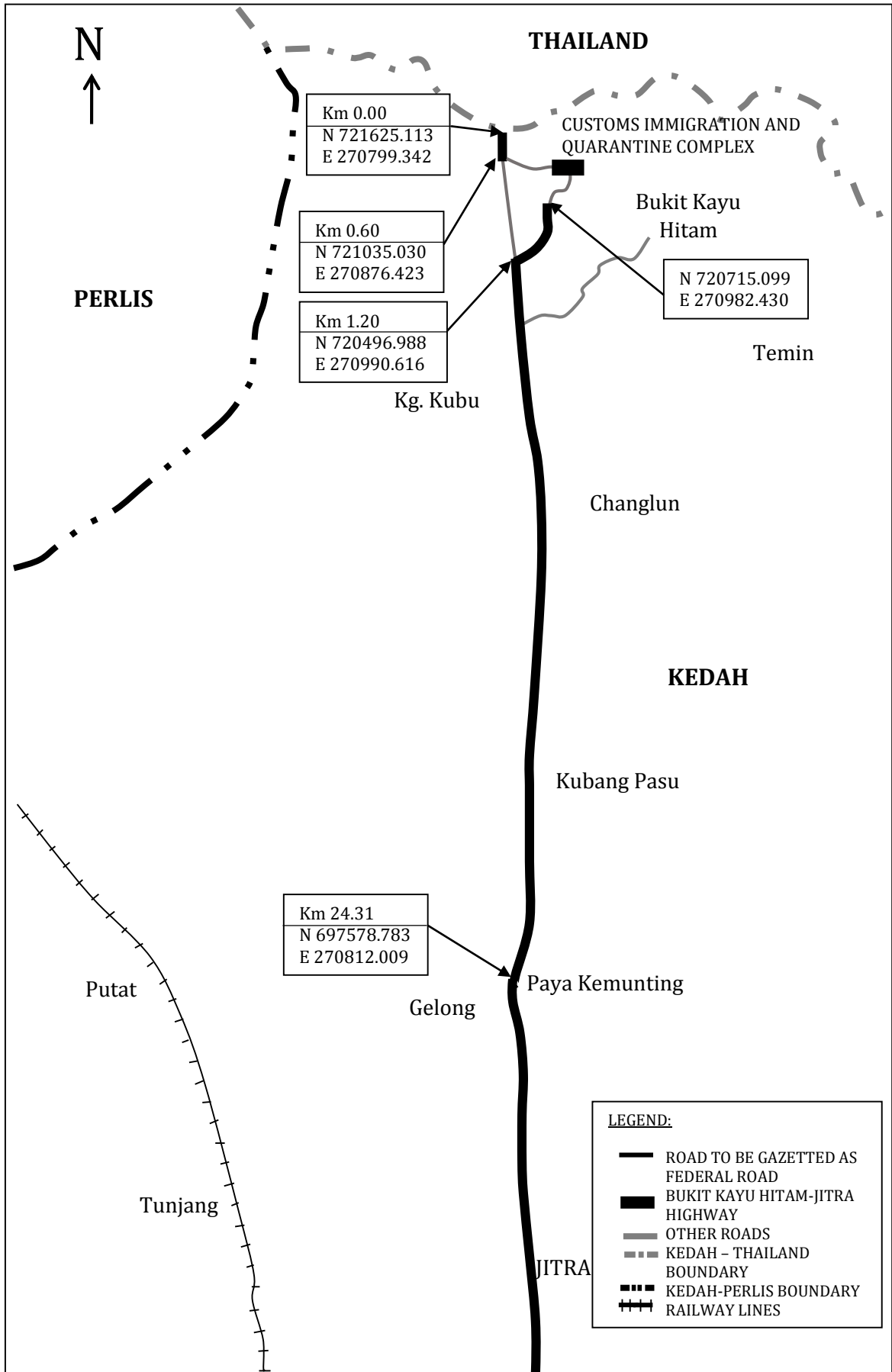
(2) This Order comes into operation on 1 January 2018.

Amendment of First Schedule

2. The Federal Roads (West Malaysia) Order 1989 [*P.U. (A) 401/1989*] is amended in the First Schedule—

(a) under the heading “Negeri Kedah Darul Aman” by substituting for the MAP: BUKIT KAYU HITAM-JITRA HIGHWAY the following map:

“MAP: BUKIT KAYU HITAM-JITRA HIGHWAY

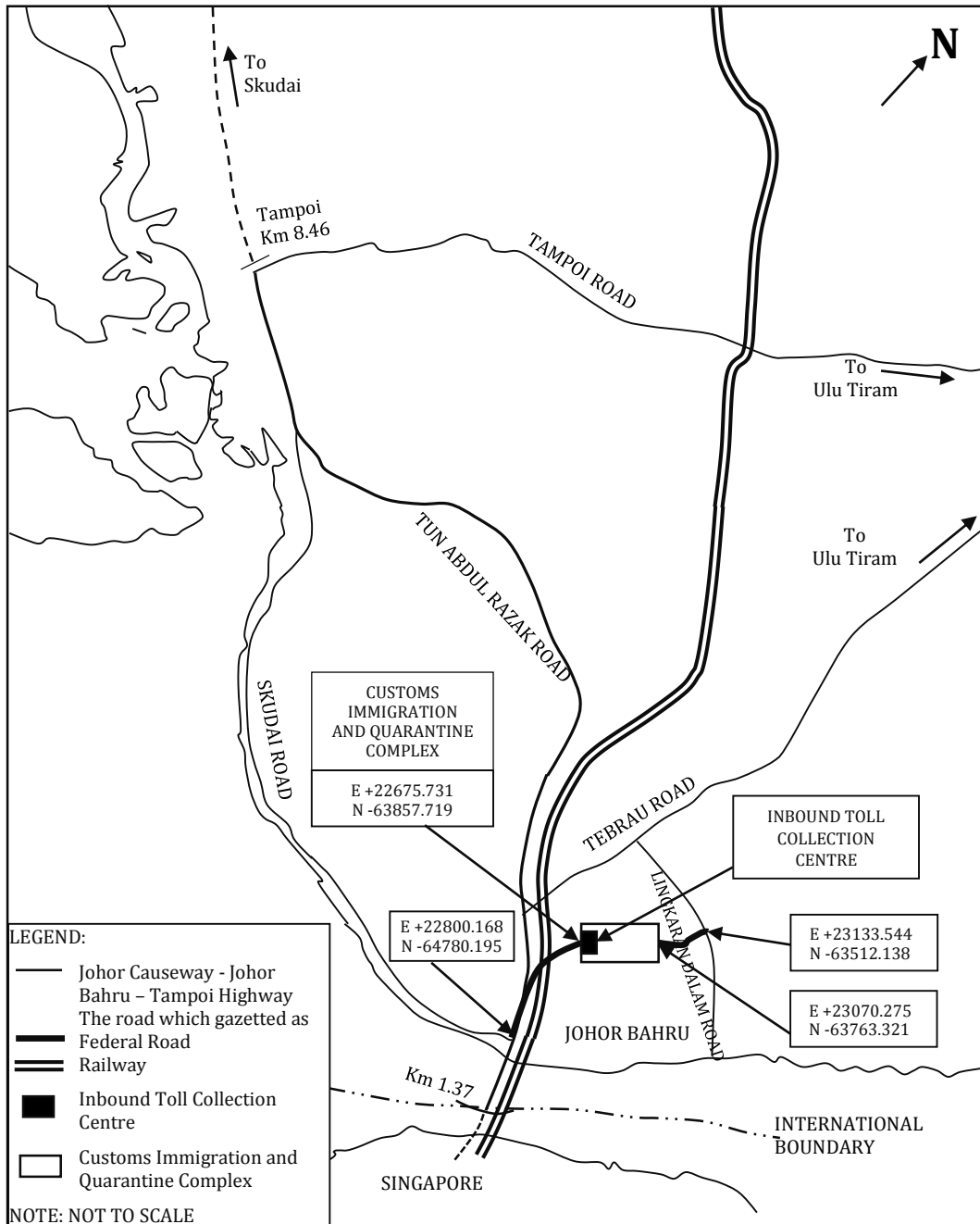


”; and

(b) under the heading “Negeri Johor”—

- (i) in item 30, by inserting after the words “Customs Immigration and Quarantine Complex” the words “which is known as the Bangunan Sultan Iskandar”; and
- (ii) by substituting for MAP 8: FEDERAL ROADS OF NEGERI JOHOR the following map:
