FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(FEDERAL HIGHWAY ROUTE 2) (REVOCATION) ORDER 2017

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [Act 306], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Federal Highway Route 2) (Revocation) Order 2017**.

(2) This Order comes into operation on 1 January 2018.

Revocation

2. The Federal Roads (Private Management) (Collection of Tolls) (Federal Highway Route 2) Order 1993 [*P.U. (A) 372/1993*] is revoked.
