FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)  
(EASTERN DISPERSAL LINK EXPRESSWAY (EDL)) (REVOCATION) ORDER 2017

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Eastern Dispersal Link Expressway (EDL)) (Revocation) Order 2017**.

(2) This Order comes into operation on 1 January 2018.
