Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Jambatan dan Lebu Raya Laluan Kedua Malaysia-Singapura dan Lebu Raya Perling) (Pindaan) 2017**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2018.

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(MALAYSIA-SINGAPORE SECOND CROSSING BRIDGE AND EXPRESSWAY AND
PERLING EXPRESSWAY) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Malaysia-Singapore Second Crossing Bridge and Expressway and Perling Expressway) (Amendment) Order 2017**.

(2) This Order comes into operation on 1 January 2018.

Amendment of Second Schedule

2. The Federal Roads (Private Management) (Collection of Tolls) (Malaysia-Singapore Second Crossing Bridge and Expressway and Perling Expressway) Order 1998 [*P.U. (A) 97/1998*] is amended in the heading of the Second Schedule by substituting for the words “31 DECEMBER 2017” the words “30 JUNE 2018”.
