PADA menjalankan kuasa yang diberikan oleh seksyen 2 Akta Jalan-Jalan Persekutuan (Pengurusan Persendirian) 1984 [*Akta 306*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Tambak Johor-Lebuh Raya Johor Bahru-Tampoi) (Pindaan) 2017**.

(2) Perintah ini mula berkuat kuasa pada 1 Januari 2018.

2. Perintah Jalan-Jalan Persekutuan (Pengurusan Persendirian) (Pungutan Tol) (Tambak Johor-Lebuh Raya Johor Bahru-Tampoi) 1989 [*P.U. (A) 14/1989*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam subperenggan 3(1) dengan menggantikan perkataan “Plaza Tol Bukit Chagar di dalam Kompleks Kastam Imigresen dan Kuarantin” dengan perkataan “Pusat Pungutan Tol Masuk di dalam Kompleks Kastam Imigresen dan Kuarantin yang dikenali sebagai Bangunan Sultan Iskandar”.

Pindaan Jadual Pertama

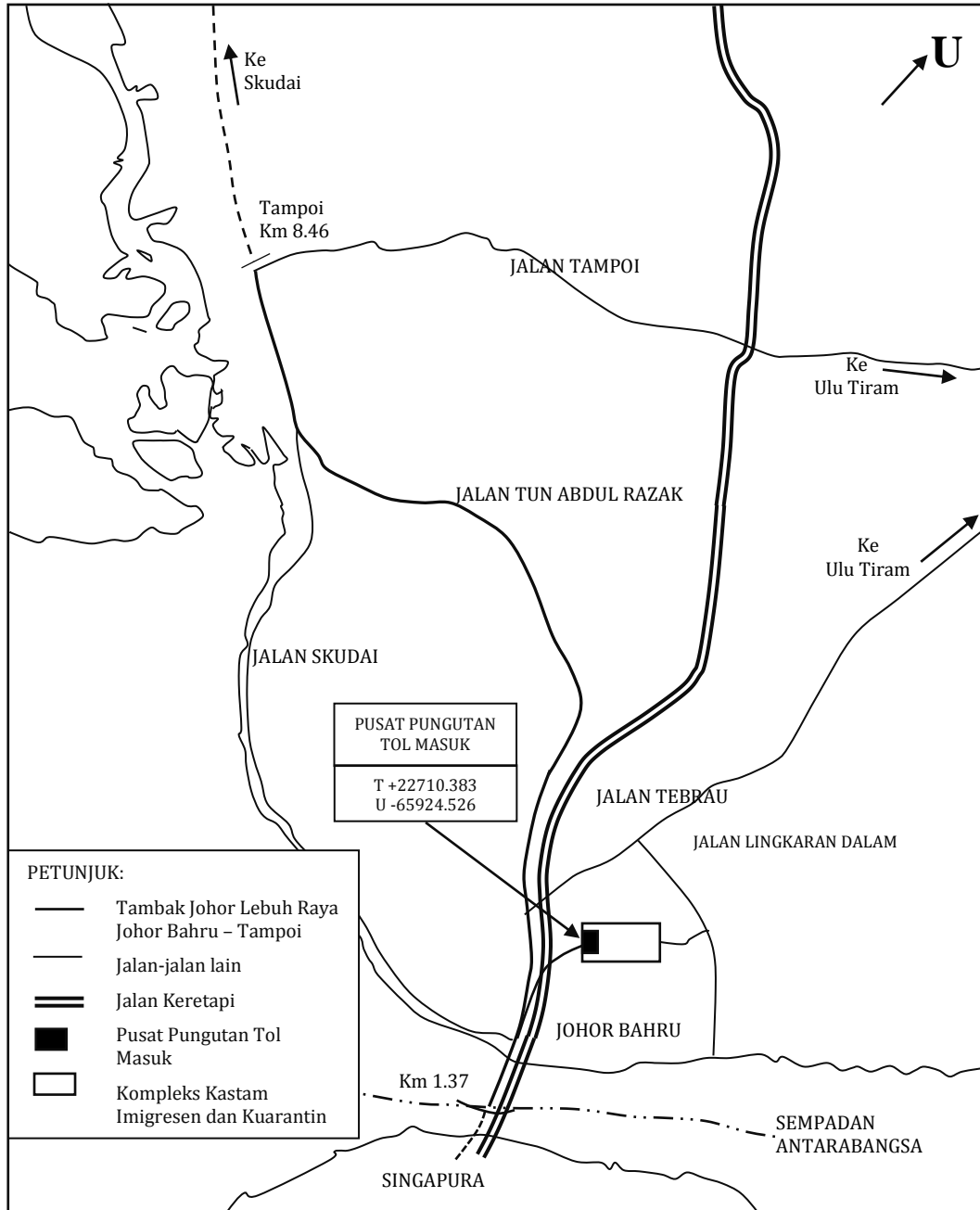

FEDERAL ROADS (PRIVATE MANAGEMENT) ACT 1984

FEDERAL ROADS (PRIVATE MANAGEMENT) (COLLECTION OF TOLLS)
(JOHOR CAUSEWAY-JOHOR BAHRU-TAMPOI HIGHWAY) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by section 2 of the Federal Roads (Private Management) Act 1984 [*Act 306*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Federal Roads (Private Management) (Collection of Tolls) (Johor Causeway-Johor Bahru-Tampoi Highway) (Amendment) Order 2017**.

(2) This Order comes into operation on 1 January 2018.

Amendment of paragraph 3

2. The Federal Roads (Private Management) (Collection of Tolls) (Johor Causeway-Johor Bahru-Tampoi Highway) Order 1989 [*P.U. (A) 14/1989*], which is referred to as the “principal Order” in this Order, is amended in subparagraph 3(1) by substituting for the words “Bukit Chagar Toll Plaza in the Customs Immigration and Quarantine Complex” the words “Inbound Toll Collection Centre in the Customs Immigration and Quarantine Complex which is known as the Bangunan Sultan Iskandar”.

Amendment of First Schedule

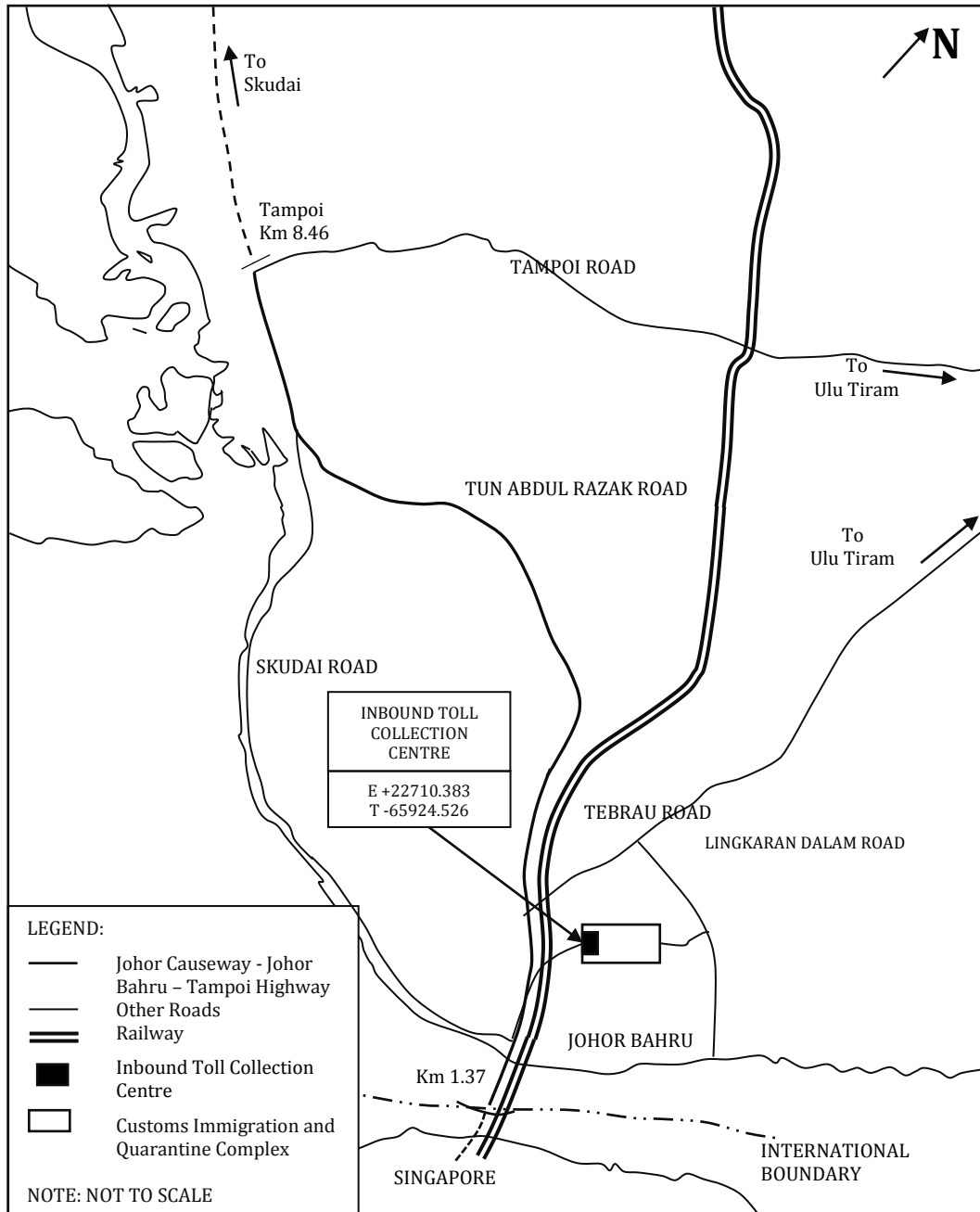
3. The First Schedule to the principal Order is amended in the heading by substituting for the words “31 DECEMBER 2017” the words “31 DECEMBER 2018”.

Substitution of Second Schedule

4. The principal Order is amended by substituting for the Second Schedule the following Schedule:
