PERATURAN-PERATURAN SURUHANJAYA PENERBANGAN MALAYSIA
(CAJ PERKHIDMATAN PENERBANGAN) (PINDAAN) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 46 dan subseksyen 98(1) Akta Suruhanjaya Penerbangan Malaysia 2015 [*Akta 771*], Suruhanjaya membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Suruhanjaya Penerbangan Malaysia (Caj Perkhidmatan Penerbangan) (Pindaan) 2017**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2018.

2. Peraturan-Peraturan Suruhanjaya Penerbangan Malaysia (Caj Perkhidmatan Penerbangan) 2016 [*P.U. (A) 100/2016*] dipinda dengan menggantikan Jadual Kedua dengan Jadual yang berikut:

MALAYSIAN AVIATION COMMISSION ACT 2015

MALAYSIAN AVIATION COMMISSION (AVIATION SERVICES CHARGES) (AMENDMENT)
REGULATIONS 2017

IN exercise of the powers conferred by section 46 and subsection 98(1) of the Malaysian Aviation Commission Act 2015 [Act 771], the Commission makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Malaysian Aviation Commission (Aviation Services Charges) (Amendment) Regulations 2017**.

(2) These Regulations come into operation on 1 January 2018.

Substitution of Second Schedule

2. The Malaysian Aviation Commission (Aviation Services Charges) Regulations 2016 [P. U. (A) 100/2016] are amended by substituting for the Second Schedule the following Schedule:
