PADA menjalankan kuasa yang diberikan oleh seksyen 5 Akta Pasaran Modal dan Perkhidmatan 2007 [*Akta 671*], Menteri, atas syor Suruhanjaya, membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Pasaran Modal dan Perkhidmatan (Penetapan Sekuriti dan Sekuriti Islam) (Nota Pelaburan dan Nota Pelaburan Islam) (Pindaan) 2017**.

(2) Perintah ini mula berkuat kuasa pada 20 Disember 2017.

**Pindaan perenggan 2**

2. Perintah Pasaran Modal dan Perkhidmatan (Penetapan Sekuriti dan Sekuriti Islam) (Nota Pelaburan dan Nota Pelaburan Islam) 2016 [*P.U. (A) 126/2016*] dipinda dalam perenggan 2 dengan menggantikan subsubperenggan (*d*) dengan subsubperenggan yang berikut:

“(d) penyata, buku akaun atau dokumen lain yang menunjukkan apa-apa baki dalam—

(i) akaun semasa, deposit atau simpanan; atau

(ii) akaun pelaburan sebagaimana yang ditakrifkan dalam subseksyen 2(1) Akta Perkhidmatan Kewangan Islam 2013 [*Akta 759*];”.

CAPITAL MARKETS AND SERVICES (PRESCRIPTION OF SECURITIES AND ISLAMIC SECURITIES) (INVESTMENT NOTE AND ISLAMIC INVESTMENT NOTE) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by section 5 of the Capital Markets and Services Act 2007 [*Act 671*], the Minister, on the recommendation of the Commission, makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Capital Markets and Services (Prescription of Securities and Islamic Securities) (Investment Note and Islamic Investment Note) (Amendment) Order 2017**.

(2) This Order comes into operation on 20 December 2017.

**Amendment of paragraph 2**

2. The Capital Markets and Services (Prescription of Securities and Islamic Securities) (Investment Note and Islamic Investment Note) Order 2016 [*P.U. (A) 126/2016*] is amended in paragraph 2 by substituting for subparagraph (d) the following subparagraph:

“(d) a statement, passbook or other document showing any balance in—

(i) a current, deposit or savings account; or

(ii) an investment account as defined in subsection 2(1) of the Islamic Financial Services Act 2013 [*Act 759*];”.
