AKTA IMIGRESEN 1959/63

PERINTAH IMIGRESEN (LARANGAN MASUK) (PINDAAN) 2017

PADA menjalankan kuasa yang diberikan oleh seksyen 9 Akta Imigresen 1959/63 [*Akta 155*], Ketua Pengarah, dengan persetujuan Ketua-Ketua Menteri Sabah dan Sarawak, membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Imigresen (Larangan Masuk) (Pindaan) 2017**.

(2) Perintah ini mula berkuat kuasa pada 15 Disember 2017.

Pindaan Jadual

2. Perintah Imigresen (Larangan Masuk) 1963 [*L.N. 227/1963*] dipinda dalam Jadual—

(a) dalam perenggan C, dengan menggantikan perkataan “six years” dengan perkataan “eighteen years”; dan

(b) dalam perenggan E, dengan menggantikan perkataan “six years” dengan perkataan “eighteen years”.

IMMIGRATION ACT 1959/63

IMMIGRATION (PROHIBITION OF ENTRY) (AMENDMENT) ORDER 2017

IN exercise of the powers conferred by section 9 of the Immigration Act 1959/63 [*Act 155*], the Director General, with the concurrence of the Chief Ministers of Sabah and Sarawak, makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Immigration (Prohibition of Entry) (Amendment) Order 2017**.

(2) This Order comes into operation on 15 December 2017.

Amendment of Schedule

2. The Immigration (Prohibition of Entry) Order 1963 [*L.N. 227/1963*] is amended in the Schedule—

(a) in paragraph C, by substituting for the words “six years” the words “eighteen years”; and

(b) in paragraph E, by substituting for the words “six years” the words “eighteen years”.
